TOWNSHIP OF ADJALA-TOSORONTIO COMMUNITY OF COLGAN MASTER SERVICING PLAN AMENDMENT SCHEDULE 'B' CLASS ENVIRONMENTAL ASSESSMENT – SUMMARY REPORT NOTICE OF COMPLETION

BACKGROUND

The Township of Adjala-Tosorontio (Township) has completed a Municipal Class Environmental Assessment (EA) process to amend the 2010 Community of Colgan Master Servicing Plan in accordance with Ministry of the Environment recommendations and in order to determine sustainable solutions for future development within the study area, the boundaries of which are identified by the shaded area in the map shown.

PROBLEM AND OPPORTUNITY STATEMENT

The Objective of the Community of Colgan Master Servicing Plan Amendment Schedule 'B' Class EA is to identify and select preferred alternative water supply and storage strategy; and, wastewater collection, treatment and disposal servicing strategies for the Community of Colgan's anticipated 20 year development horizon. The preferred strategies minimize impacts to both the natural and social environments and are both technically feasible and economically sensible.

PROCESS

This Study has been undertaken in accordance with the requirements for Schedule 'B' Projects as identified in the Municipal Engineers Association (MEA) Class EA document which is approved under the Ontario Environmental Assessment Act, and will satisfy Phases 1 and 2 of the Class EA planning process.

The preferred master water servicing solution for Colgan included increasing the Current MOE Permit to Take Water (PTTW) and Well Capacity of current water supply for the ultimate water demand and construction of In-ground/at-grade storage with booster pumping. The preferred master wastewater servicing solution for Colgan includes split gravity and forcemain flow, using either conventional gravity sewers or low-slope, small diameter sewer with lot-level pre-treatment tanks conveyed to a wastewater treatment plant (WWTP) with 0.05 mg/L Phosphorous Treatment utilizing Surface Water Discharge to Bailey Creek. The WWTP is a Schedule 'C' Project and must complete Phases 3 and 4 of the EA process prior to implementation.

A Public Information Centre (PIC) was held on Wednesday May 20th, 2015 from 3:00 PM to 7:00 PM. Subject to comments received as a result of this notice, the Township will be able to proceed with the implementation of the recommended Schedule A, A+ and B projects included in the Class EA Master Plan Study Report.

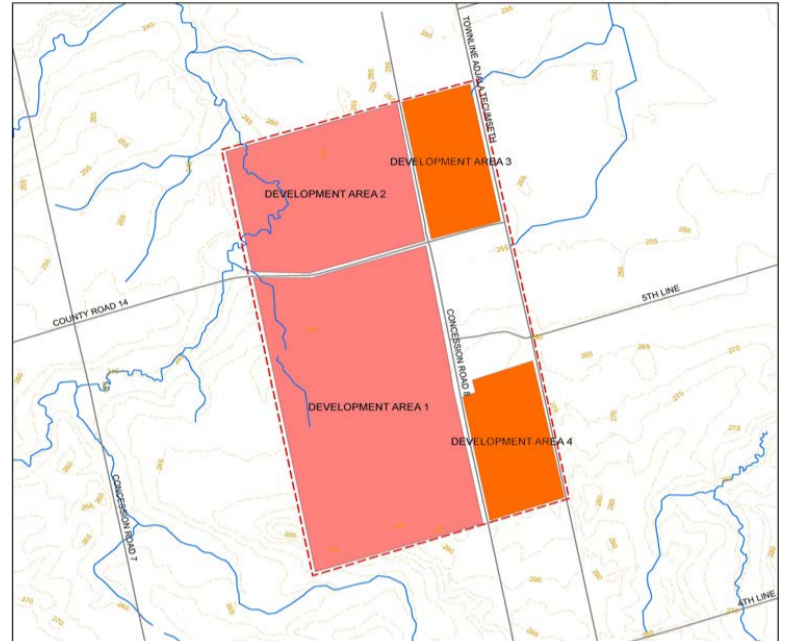
PUBLIC COMMENT INVITED
