Joint Accessibility Advisory Committee – Application Form (2018-2022 Term of Office)

The Joint Accessibility Advisory Committee, with the County of Simcoe and Area Municipalities, shall advise and assist the Township of Adjala-Tosorontio in promoting and facilitating a barrier-free Township for citizens of all abilities (universal accessibility), including persons with disabilities. This aim shall be achieved through the review of policies, programs and services and the identification, removal and prevention of barriers faced by persons with disabilities.

The Joint Committee is comprised of members from across the County of Simcoe, with the majority of the members being persons with disabilities. As a member of the Joint Committee the Township of Adjala-Tosorontio will appoint one citizen member and one Council representative, with administrative assistance from the Clerk's Department. The Committee will meet at the Simcoe County Administration Building in Midhurst, and citizen members are compensated in accordance with the existing policies of the Corporation of the County of Simcoe
