### Colgan Community - Wastewater Treatment Plant and Outfall

#### Class Environmental Assessment Study (Phases 3 and 4)

#### **\*REVISED\* - Notice of Completion of Environmental Study Report**

#### THE PROJECT

In January 2016, the Township of Adjala-Tosorontio completed the Colgan Master Servicing Plan Amendment, which identified a preferred wastewater servicing solution for approved growth areas in the Community of Colgan. The Master Servicing Plan satisfied Phases 1 and 2 of the Municipal Class Environmental Assessment (Class EA) process for the wastewater projects, which are subject to Schedule C of the Municipal Class EA.

Tribute Communities (the Proponent) has now completed the Schedule C Project (Phases 3 and 4 of the Class EA process) to identify the preferred locations and design concepts for the wastewater treatment plant (WWTP), forcemain and outfall to service the growth areas. The preferred locations are shown in the figure. The proposed WWTP will be located within the planned development off County Road 14, Colgan. The proposed outfall for the WWTP will be located at Bailey Creek on Concession Road 8. The conveyance of treated wastewater from the WWTP to the outfall will be through a proposed forcemain and gravity pipe located along Concession Road 8.

The Environmental Study Report has been completed and by this Notice is being placed in the public record for review and comment. Subject to comments received as a result of this Notice and the receipt of necessary approvals, the proponent intends to proceed with implementation of this project as described in the Environmental Study Report.


