

DECISION:


The requested Minor Variance **to permit construction of a detached one storey accessory storage structure located a minimum of 38m from the front lot line be**

GRANTED.







Additional information regarding this application is available for perusal at the Municipal Office during normal business hours.

If you wish to be notified of the decision of the Committee of Adjustment for the Corporation of the Township of Adjala-Tosorontio in respect of this application, you must submit a written request to the Secretary/Treasurer of the Committee of Adjustment. This will also entitle you to be advised of a possible Ontario Municipal Board Hearing. Even if you are the successful party, you should request a copy of the decision since the Committee of Adjustment decision may be appealed to the Ontario Municipal Board by the applicant or another member of the public.

Any person or public body who has made an oral submission at the public meeting or made written submission to the public meeting may, within twenty (20) days of the making of the decision under section 45(8), appeal to the Municipal Board against the decision by filing with the Secretary-Treasurer for the Committee of Adjustment an Appellant Form setting out written reasons in support of the appeal and accompanied by payment in the form of a certified cheque or money order to the Ontario Minister of Finance of the fee prescribed by the Board under the Ontario Municipal Board Act. Only individuals, corporations and public bodies may appeal decisions in respect of applications for minor variances to the Ontario Municipal Board. An Appellant Form may not be filed by an unincorporated association or group. However, an Appellant Form may be filed in the name of an individual who is a member of the association or group. The Ontario Municipal Board may dismiss the appeal if the appellant did not make oral submissions at the public meeting or did not made written submissions to the Committee before the minor variance was granted or denied and if in the opinion of the Board the appellant does not provide a reasonable explanation for having failed to make a submission.

The date of the notice of decision is Friday, October 13, 2017.

The last day for appealing this decision is Tuesday, October 31, 2017.

The Ontario Municipal Board's fee currently is \$300.00 for the appeal of this application, payable by certified cheque or money order to the Ontario Minister of Finance.
