BY-LAW 10-44

A BY-LAW TO PROVIDE FOR THE IMPOUNDING OF ANIMALS RUNNING AT LARGE

WHEREAS the Pounds Act R.S.O. 1990, c. P.17, as amended, provide the authority for a municipality to pass a by-law for the impounding of animals unlawfully being at large; the sale of impounded animals if they are not claimed or if the damages, fines and expenses are not paid according to law; the establishment of procedures of the voluntary payment of penalties out of court where it is alleged that the by-law has been contravened; and to appoint a Poundkeeper;

AND WHEREAS it has been deemed necessary and expedient to appoint a Poundkeeper for the Corporation of the Township of Adjala – Tosorontio, to set poundage fees and to provide for the remuneration to be paid to the Poundkeeper for services rendered in carrying out the duties of the Poundkeeper;

NOW THEREFORE the Council of the Corporation of the Township of Adjala – Tosorontio enacts as follows:

1. **THAT** Council appoint a Poundkeeper to carry out the provisions of the Pounds Act, R.S.O. 1990, Chapter P.17, as amended;
2. **THAT** it shall be the duty of the Poundkeeper to impound any animal delivered to him and shall be dealt with pursuant to the provisions of the Pounds Act R.S.O. 1990.
3. **THAT** every owner or occupant of any land is liable for any damages caused by any animal in the owner's or occupant's care as set out in the Pounds Act R.S.O. 1990, c. 17, as amended.
4. **THAT** the poundage fees in the Township of Adjala – Tosorontio shall be set as provided for in the Township Fees and Charges By-law, as amended and that the remuneration payable to the Poundkeeper for services rendered in carrying out his duties shall be all the fees and collected by the Poundkeeper.

5. **THAT** this By-law shall apply to all of the Township of Adjala – Tosorontio;
6. **THAT** By-law 99-9 is hereby repealed;
7. **THAT** the provisions of this By-law shall take full force and effect with the passing hereof;
8. **THAT**, notwithstanding anything contrary to the rules of procedure, this By-law be introduced and read a first and second time and be considered read a third time and finally passed this 20th day of December, 2010.
