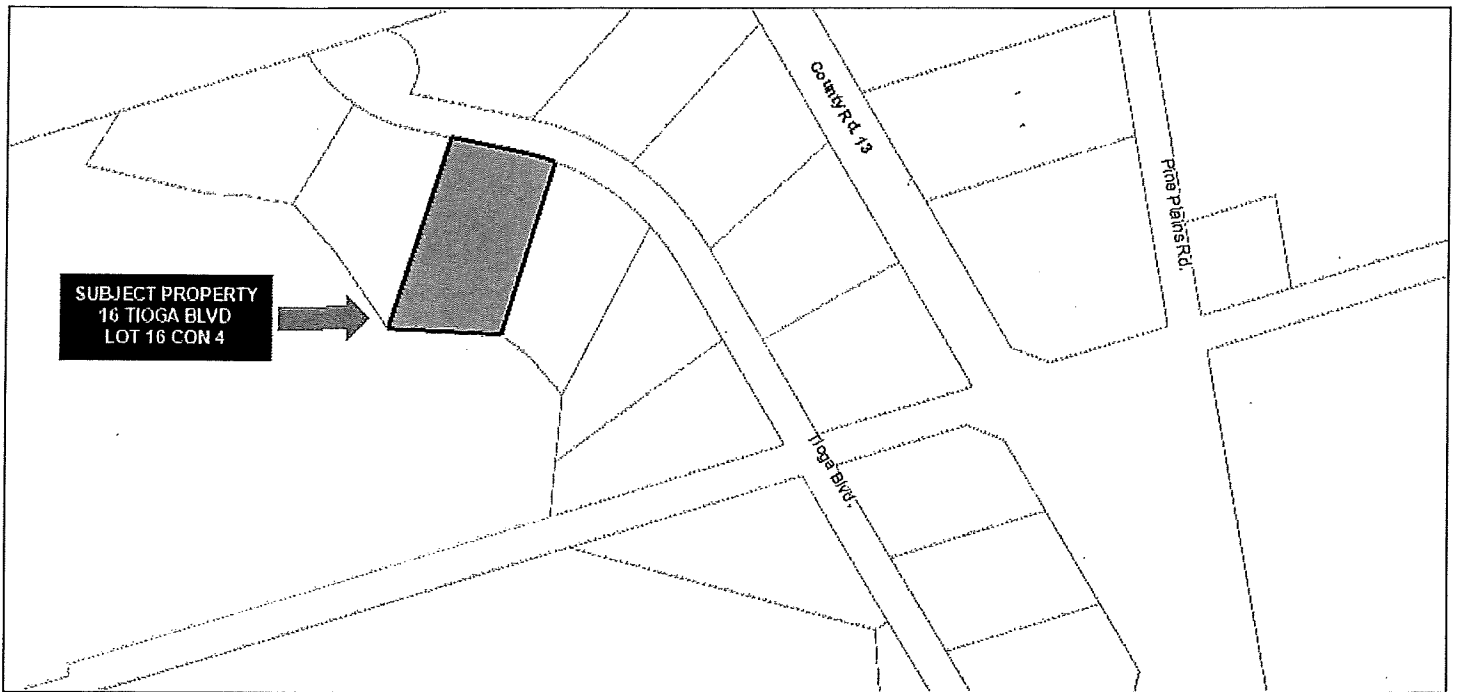
If you do not attend at the hearing it may proceed in your absence and, except as otherwise provided in the Planning Act, you will not be entitled to any further notice in the proceedings.

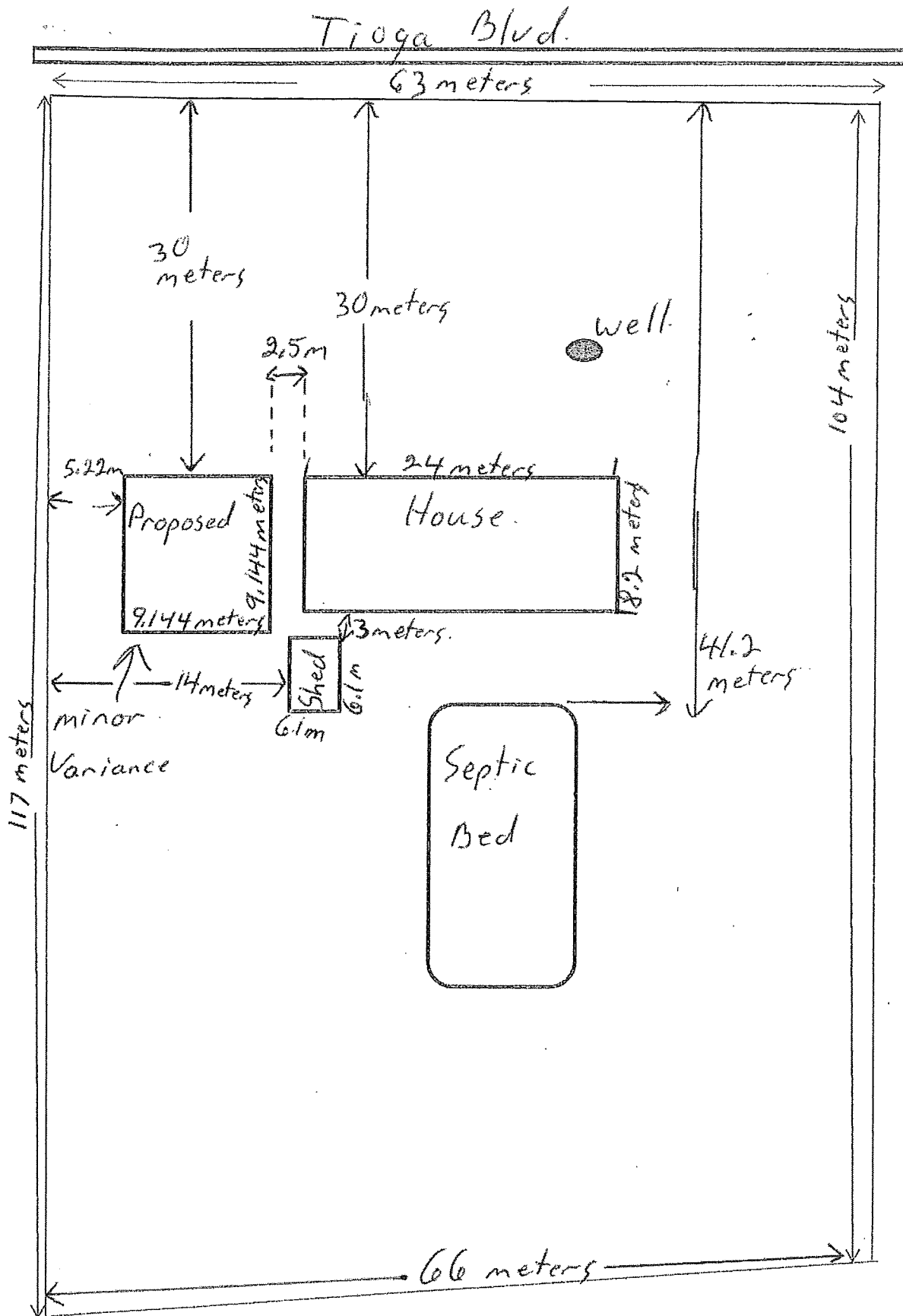
If you wish to be notified of the decision of the Committee of Adjustment in respect of the requested minor variance, you must have appeared in person or by counsel at the hearing and have filed with the secretary/treasurer a written request for notice to the Committee of Adjustment at the above noted address according to Section 45(10). The Planning Act requires that you be notified that if a person or public body who has an interest in the matter files an appeal of a decision of the Committee of Adjustment in respect of the requested minor variance the Ontario Municipal Board may dismiss all or part of the appeal without holding a hearing under section 45(17) of the Planning Act, R.S.O. 1990.

**EXPLANATION OF THE PURPOSE AND EFFECT
OF THE PROPOSED MINOR VARIANCE
A/04/17**

Application has been made for a minor variance to Township Zoning By-law No. 03-57 under file number A/04/17 to allow construction of a detached one storey accessory storage structure to have a maximum gross floor area of 85m² which is larger than permitted on Lot 16, Concession 4, Geographic Township of Tosorontio, Township of Adjala-Tosorontio (16 Tioga Blvd).





Maximum height of Proposed building will not exceed the highest point of any existing building which is 6.2 meters
