SYNOPSIS: To prohibit residential uses on the retained farmland created through the severance of a surplus dwelling (9156 County Road 5).

TAKE NOTICE that the Council of the Corporation of the Township of Adjala-Tosorontio has received an application under the Planning Act, R.S.O. 1990, as amended, for a Zoning By-law Amendment for property located on Part of Lot 9, Concession 3, geographic Township of Adjala, Township of Adjala-Tosorontio (2074 Concession Road 3).

AND TAKE NOTICE that the Council of the Corporation of the Township of Adjala-Tosorontio will hold a Public Meeting to consider a Zoning By-law Amendment under Section 34 of the Planning Act, as amended, on:

MONDAY February 12th, 2018

The Public Meeting is scheduled to start at **6:30pm** or as shortly thereafter as possible, depending on the number of meetings being held on this date. The Public Meeting will be held in the **Municipal Council Chambers at 7855 30th Sideroad Adjala.**

Any person may attend the public meeting and/or make written or verbal representation either in support of, or in opposition to, the Zoning By-law Amendment.

If a person or public body does not make oral submissions at a public meeting or make written submissions to the Township of Adjala-Tosorontio before the by-law is passed, the person or public body is not entitled to appeal the decision of the Township of Adjala-Tosorontio to the Ontario Municipal Board.

If a person or public body does not make oral submissions at a public meeting, or make written submissions to the Township of Adjala-Tosorontio before the by-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Municipal Board unless, in the opinion of the Board, there are reasonable grounds to do so.

If you wish to be notified of the approval of the proposed Zoning By-law Amendment, you must make a written request to the Township of Adjala-Tosorontio, 7855 30th Sideroad Adjala, Alliston, Ontario, L9R 1V1.

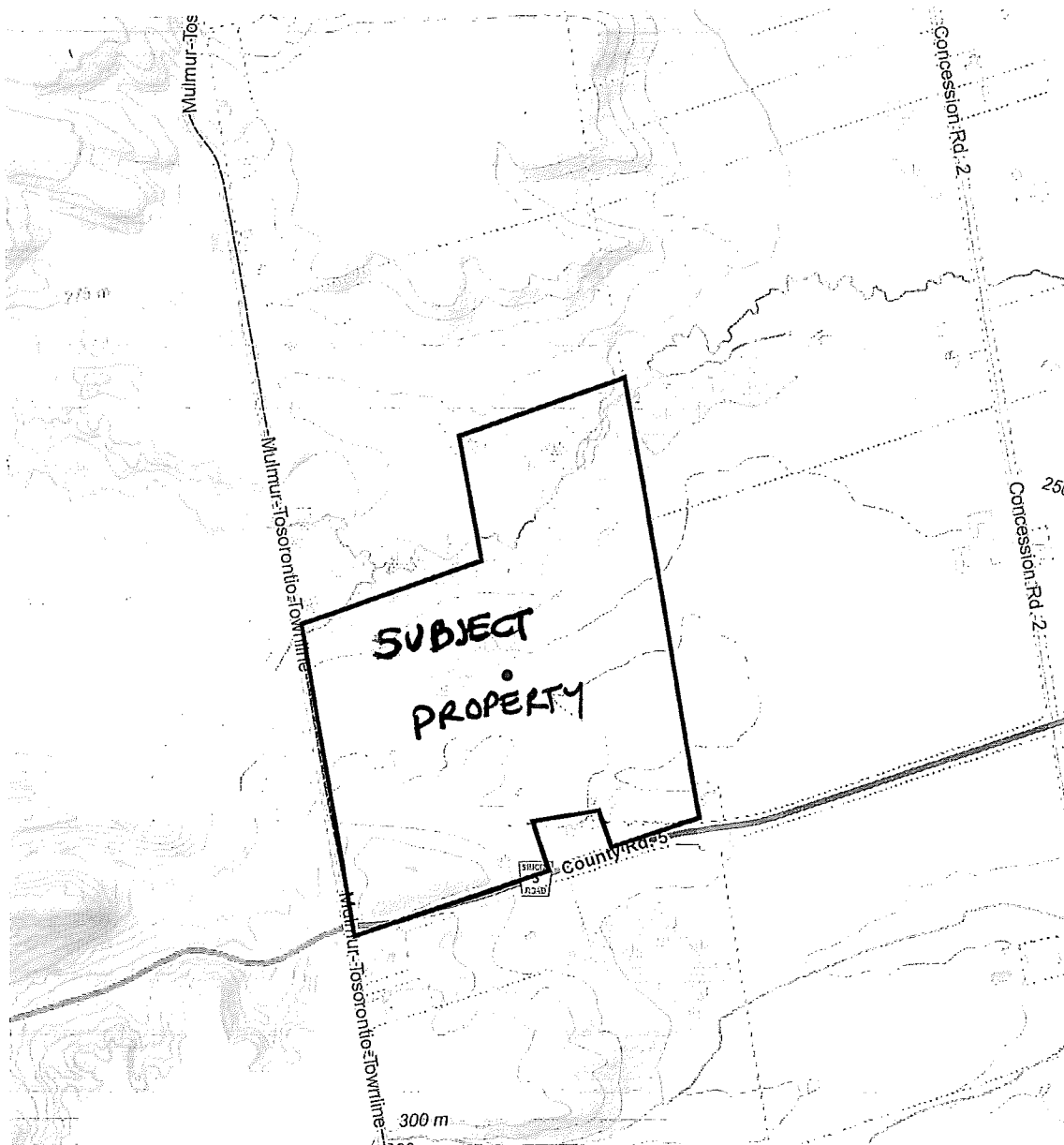

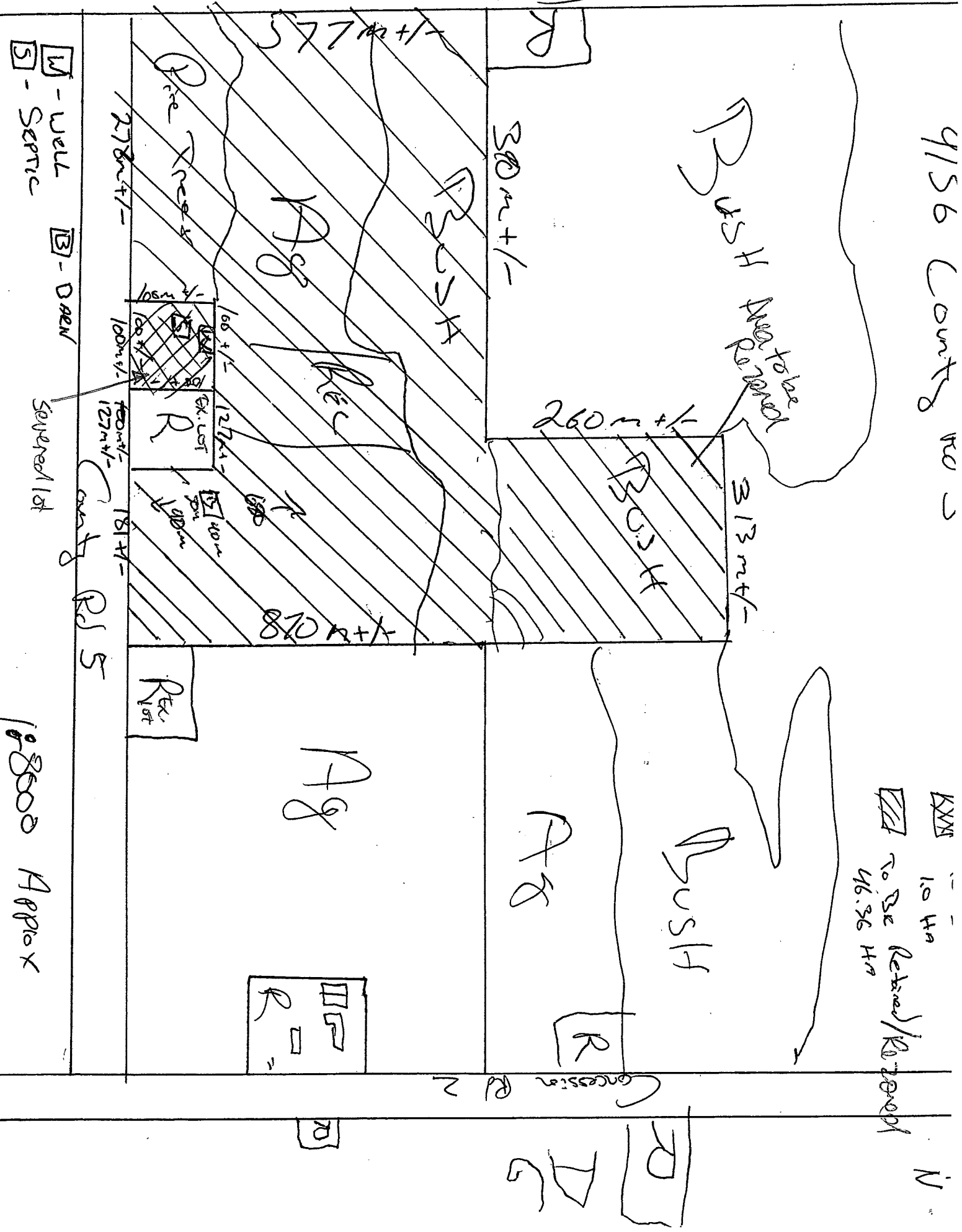
**EXPLANATION OF THE PURPOSE AND EFFECT
OF THE PROPOSED ZONING AMENDMENT
Z/10/17 (9156 County Road 5)**

Application has been made for rezoning (Z/10/17) on lands located on Part of Lot 11, Concession 1, geographic Township of Tosorontio, Township of Adjala-Tosorontio (9156 County Road 5). The proposal is to prohibit residential uses on a portion of the property, as a result of a recently approved consent application to sever the surplus residential dwelling from the farm property.

BY-LAW NO. 18 –

**A BY-LAW TO AMEND ZONING BY-LAW NO. 03-57, AS AMENDED OF
THE TOWNSHIP OF ADJALA-TOSORONTIO**

**Part of Lot 11, Concession 1, geographic Township of Tosorontio
9156 County Road 5 (4301-020-003-00301)**

WHEREAS Zoning By-law No. 03-57, as amended, constitutes the comprehensive Zoning By-law for the Township of Adjala-Tosorontio save and except those lands within the Oak Ridges Moraine area;

AND WHEREAS it is deemed necessary and desirable to further amend By-law No. 03-57, as amended;

AND WHEREAS this amendment will conform to the Official Plan of the Township of Adjala-Tosorontio;

**NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE
TOWNSHIP OF ADJALA-TOSORONTIO ENACTS AS FOLLOWS:**

1. **THAT** Schedule "A-5" of By-law No. 03-57, as amended, is hereby further amended by changing the zoning on Part of Lot 11, Concession 1, geographic Township of Tosorontio, from an Agricultural (A) Zone to an Agricultural Exception 114 (A-114) Zone, as shown hatched on Schedule "A", attached hereto.

2. **THAT** Section 4.4 - Zone Exceptions for the Agricultural Zone in By-law No. 03-57, as amended, is hereby further amended as follows:

Section 4.4.113 (A-114 Zone)

Notwithstanding anything to the contrary found in this By-law, residential uses are not permitted. All other provisions of the Agricultural zone continue to apply.

3. **THAT** Schedule "A" is hereby declared to form part of this By-law.

4. **THAT** this By-law shall come into force on the date of passage and take effect the day after the last date for filing a notice of appeal where no notice of appeal is received, or, where a notice of appeal is received, upon the approval of the Ontario Municipal Board, and, in either case, in accordance with the provisions of Section 24(2) of the Planning Act, R.S.O. 1990, Ch. P.13, as amended.

5. **THAT** notwithstanding anything contrary to the rules of procedure, this By-law, having been introduced and read a first and second time, be considered read a third time and finally passed this ___ day of _____, 2018.
