**SYNOPSIS: To allow an oversized garage (2696 Concession Road 3).**

**TAKE NOTICE** that the Council of the Corporation of the Township of Adjala-Tosorontio has received an application under the Planning Act, R.S.O. 1990, as amended, for a Zoning By-law Amendment for property located on Part of Lot 14, Concession 2, geographic Township of Adjala, Township of Adjala-Tosorontio (2696 Concession Road 3).

**AND TAKE NOTICE** that the Council of the Corporation of the Township of Adjala-Tosorontio will hold a Public Meeting to consider a Zoning By-law Amendment under Section 34 of the Planning Act, as amended, on:

**MONDAY July 10<sup>th</sup>, 2017**

The Public Meeting is scheduled to start at **6:30pm** or as shortly thereafter as possible, depending on the number of meetings being held on this date. The Public Meeting will be held in the **Municipal Council Chambers** at **7855 30<sup>th</sup> Sideroad Adjala**.

Any person may attend the public meeting and/or make written or verbal representation either in support of, or in opposition to, the Zoning By-law Amendment.

If a person or public body does not make oral submissions at a public meeting or make written submissions to the Township of Adjala-Tosorontio before the by-law is passed, the person or public body is not entitled to appeal the decision of the Township of Adjala-Tosorontio to the Ontario Municipal Board.

If a person or public body does not make oral submissions at a public meeting, or make written submissions to the Township of Adjala-Tosorontio before the by-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Municipal Board unless, in the opinion of the Board, there are reasonable grounds to do so.

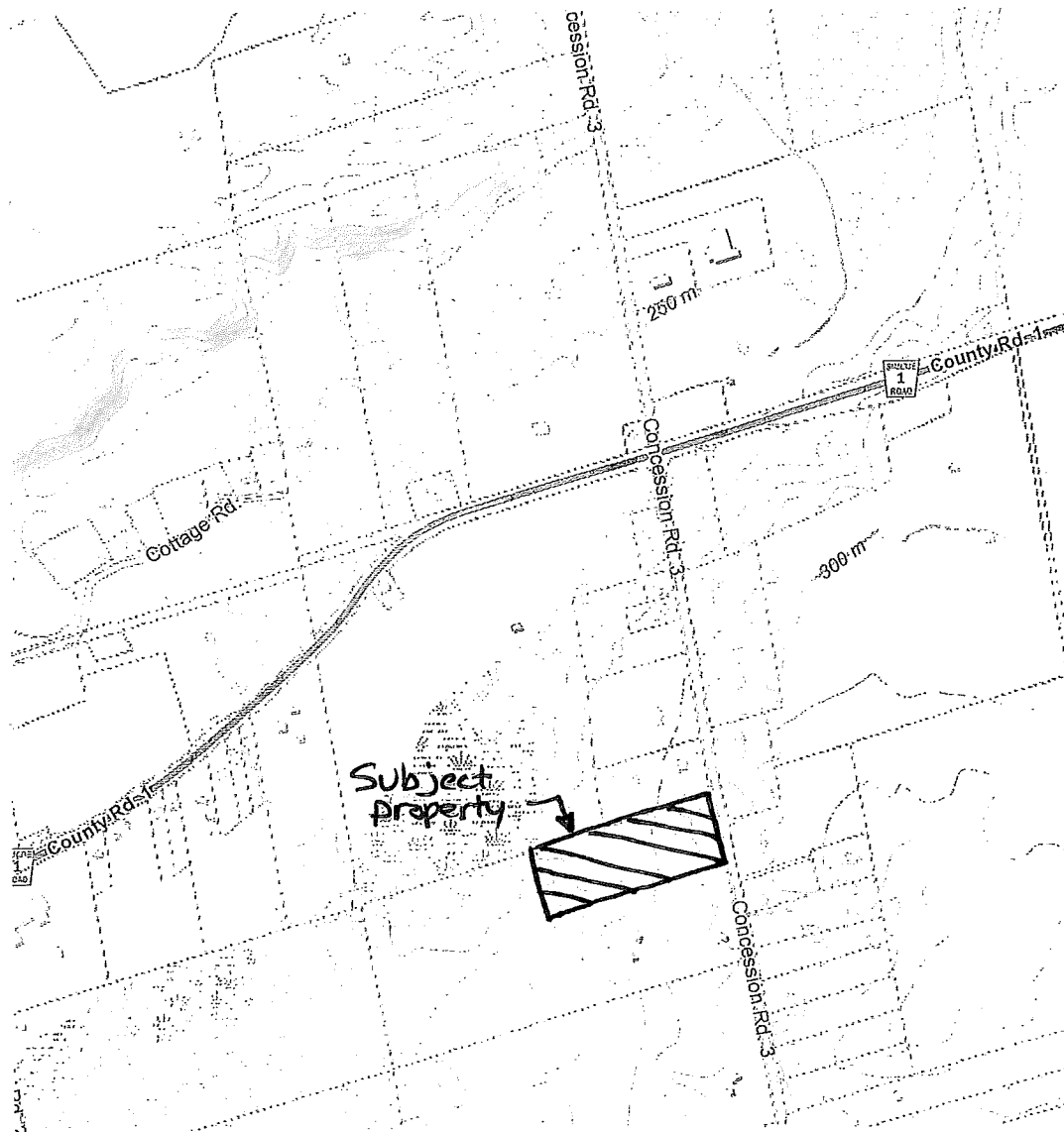

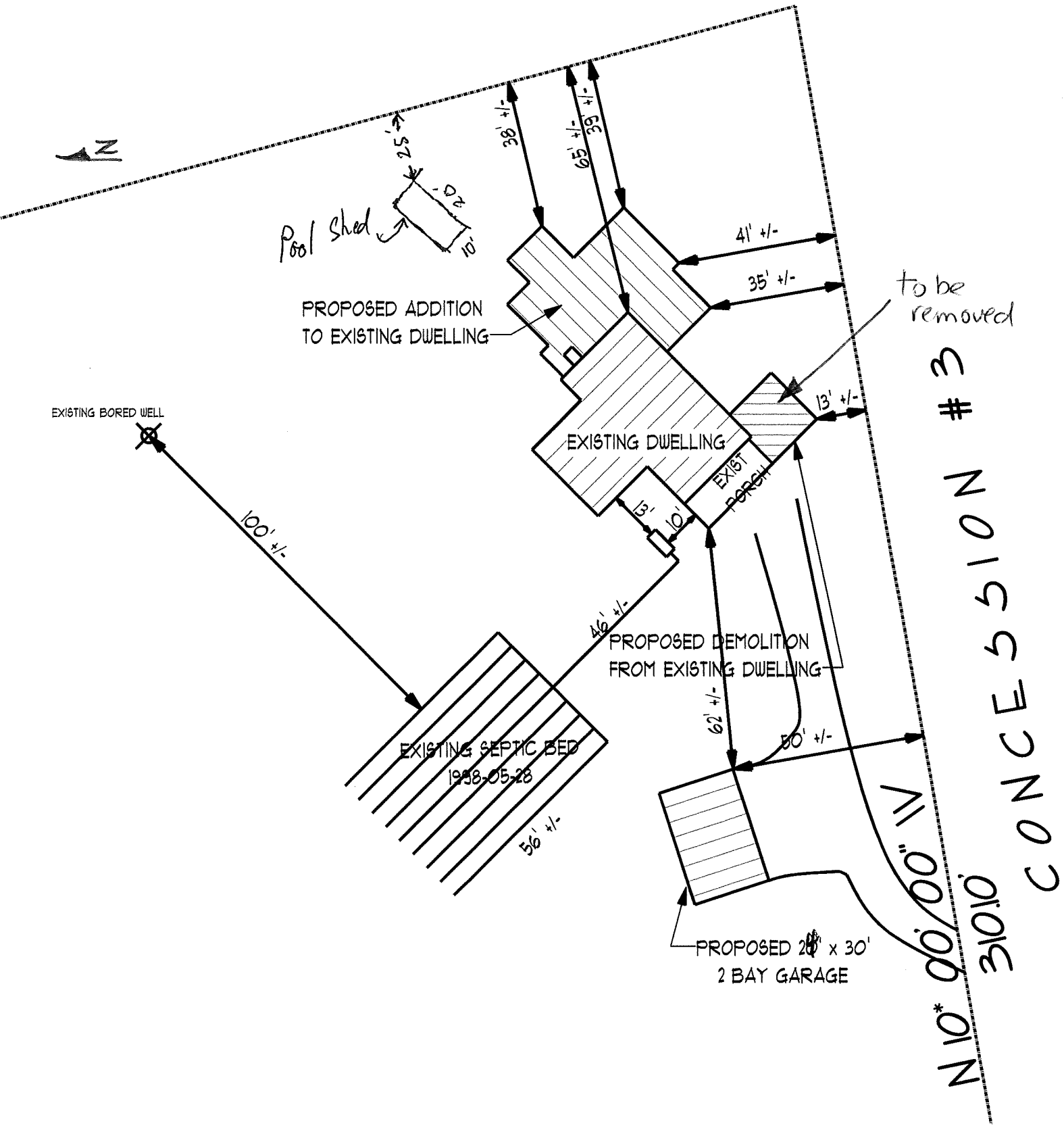

**EXPLANATION OF THE PURPOSE AND EFFECT  
OF THE PROPOSED ZONING AMENDMENT  
Z/02/17 (2696 Concession Road 3)**

Application has been made for rezoning (Z/02/17) on lands located on Part of Lot 14, Concession 2, geographic Township of Adjala, Township of Adjala-Tosoronto (2696 Concession Road 6). The proposal is to re-zone the lands to permit an accessory structure with a maximum footprint of 70m<sup>2</sup> and a maximum gross floor of 210m<sup>2</sup>. The applicant is also proposing to remove an existing accessory structure, a Natural Heritage Evaluation has been submitted in support of the proposal, and the property is under site plan control.

BY-LAW NO. 17 -

**A BY-LAW TO AMEND ZONING BY-LAW NO. 03-56, AS AMENDED,  
OF THE TOWNSHIP OF ADJALA-TOSORONTIO**

**Part of Lot 14, Concession 2, geographic Township of Adjala  
2696 Concession Road 3 (4301-010-005-12500)**

**WHEREAS** Zoning By-law No. 03-56, as amended, constitutes the comprehensive Zoning By-law for the Township of Adjala-Tosorontio for those lands within the Oak Ridges Moraine area;

**AND WHEREAS** it is deemed necessary and desirable to further amend By-law No. 03-56, as amended;

**AND WHEREAS** this amendment will conform to the Official Plan of the Township of Adjala-Tosorontio;

**NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF ADJALA-TOSORONTIO ENACTS AS FOLLOWS:**

1. THAT Schedule "A-2" of By-law No. 03-56, as amended, is hereby further amended by changing the zoning on Part of Lot 14, Concession 2 of the geographic Township of Adjala, from an Oak Ridges Moraine Conservation Zone to a Site Specific Zone Exception 14.8 Zone, as shown hatched on Schedule "A", attached hereto.
2. THAT Section 14.0 – Site Specific Zone Exception under By-law No. 03-56, as amended, is hereby further amended as follows:

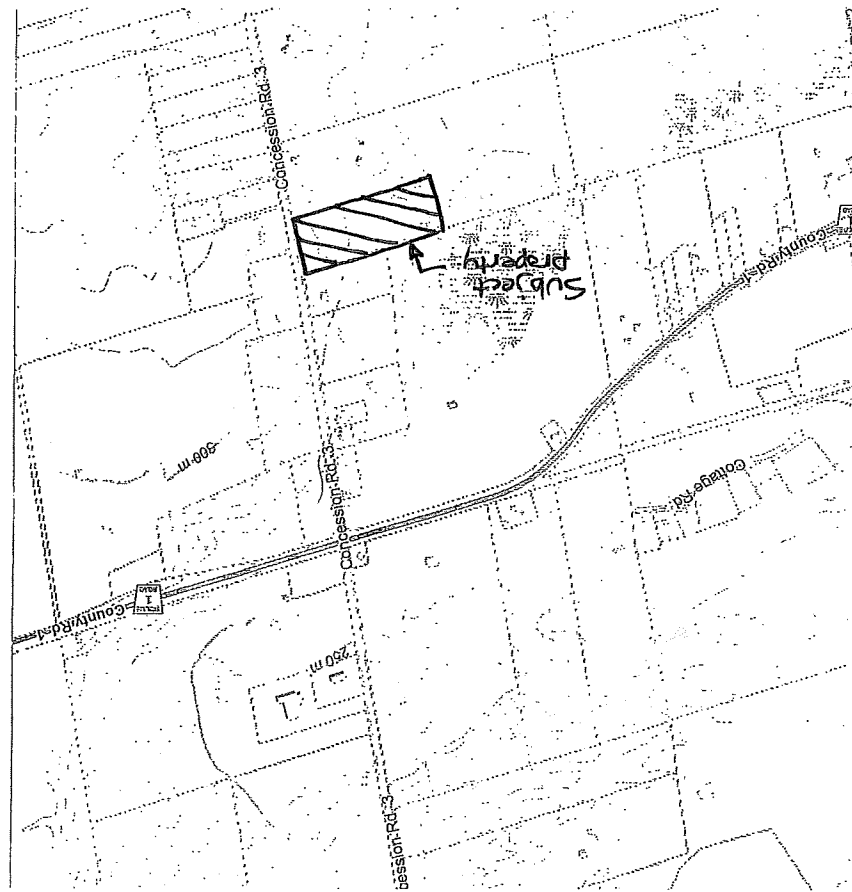
**Section 14.8 2696 Concession Road 3 Adjala**

Notwithstanding anything contrary found in this By-law, one accessory structure with a maximum footprint of 70m<sup>2</sup> and a maximum gross floor area of 210m<sup>2</sup> is a permitted use.

3. THAT Schedule "A" is hereby declared to form part of this By-law.
4. THAT this By-law shall come into force on the date of passage and take effect the day after the last date for filing a notice of appeal where no notice of appeal is received, or, where a notice of appeal is received, upon the approval of the Ontario Municipal Board, and, in either case, in accordance with the provisions of Section 24(2) of the Planning Act, R.S.O. 1990, Ch. P.13, as amended.
5. THAT, notwithstanding anything contrary to the rules of procedure, this By-law, having been introduced and read a first and second time, be considered read a third time and finally passed this \_\_\_\_ day of \_\_\_\_\_, 2017.
