PURSUANT to Section 45 of the *Planning Act* with respect to the above noted Application the Committee of Adjustment ("Committee"):

The Committee hereby **does not** authorize the Minor Variance Application requesting relief from the Township of Adjala-Tosorontio Zoning By-law **03-57** as amended, in order vary the following provision of the by-law:

 To alter the required rear yard set back from 7.5 m to 3 m for a proposed residential accessory structure and the frontage from the required 60 m to 55m, as applied for in application number D13/A10/20].

The effect of the application is to allow: **conditions for a residential lot for Consent Application D10/B03/20.**

[The authorization is subject to the conditions appended to this notice of decision.]

In consideration of all written and oral submission made, the Committee has determined that the Application **is not** a Minor Variance as:

- The requested relief does not meet the general intent of the Official Plan;
- The requested relief **does not** meet the general intent of the Zoning By-law;
- The requested relief does not constitute desirable development of the lot; and
- The requested relief is not minor in nature.


