The Committee hereby **does not** authorize the Minor Variance Application requesting relief from the Township of Adjala-Tosorontio Zoning By-law **03-57** as amended, in order vary the following provision of the by-law:

To permit a minimum lot area for the retained lot with an agricultural use to be 30.357ha, within the Rural (R) Zone.


