The Committee hereby **does not** authorize the Minor Variance Application requesting relief from the Township of Adjala-Tosorontio Zoning By-law **03-57** as amended, in order vary the following provision of the by-law:

**To permit a minimum lot area for the retained lot with an agricultural use to be 30.357ha, within the Rural (R) Zone.**

In consideration of all written and oral submission made, the Committee has determined that the Application **is** a Minor Variance as:

- The requested relief **does not** meet the general intent of the Official Plan
- The requested relief **does not** meet the general intent of the Zoning By-law
- The requested relief **does not** constitute desirable development of the lot; and

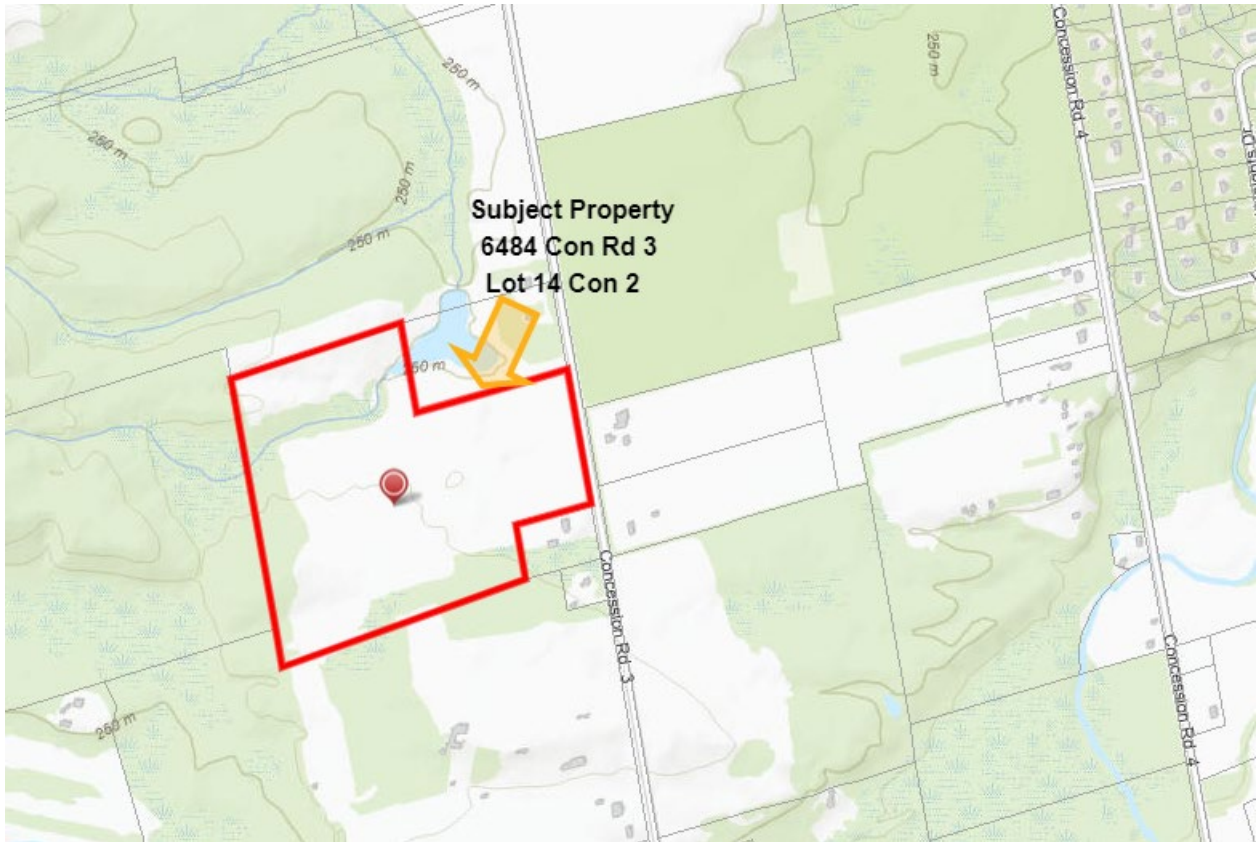
