# EXPLANATION OF THE PURPOSE AND EFFECT OF THE PROPOSED CONCURRENT CONSENTS B/07/21 & B/08/21 (Van Stralen & Bateman)

An application has been made under file number B/07/21 for consent to sever lands for a boundary line adjustment from Pt Lot 20, Concession 2, Geographic Township of Adjala, Township of Adjala-Tosorontio (3346 Concession Road 3). An application has been made under file number B/08/21 for consent to sever lands for a boundary line adjustment from Pt Lot 20, Concession Road 2, Geographic Township of Adjala, Township of Adjala-Tosorontio (3348 Concession Road 3). The proposals are to adjust the current property lines to recreate the two lots, but the area of the two lots will remain the same. The subject properties are approximately 6ha in area with frontage of about 224.62m along Concession Road 3 and 29ha with a frontage of approximately 387.13m along Concession Road 3 and 449.51m along 20<sup>th</sup> Sideroad. The proposal will result in two new shaped lots, but the area of the lots will remain the same.
