The Committee hereby **[does]** authorize the Minor Variance Application requesting relief from the Township of Adjala-Tosorontio Zoning By-law **[03-56]** as amended, in order vary the following provision of the by-law:

 To alter the required gross floor area from 58 squared metres to 112 squared metres for a proposed residential accessory structure as applied for in application number D13/A02/20].

The effect of the application is to allow: construction of a residential accessory structure of the existing lot for the purposes of providing storage.

[The authorization is subject to the conditions appended to this notice of decision.]

In consideration of all written and oral submission made, the Committee has determined that the Application **[is]** a Minor Variance as:


