to permit construction of an addition to a legal non-complying structure with a minimum front yard setback of 21 metres, within the Oak Ridges Moraine Linkage (ORM L) Zone.

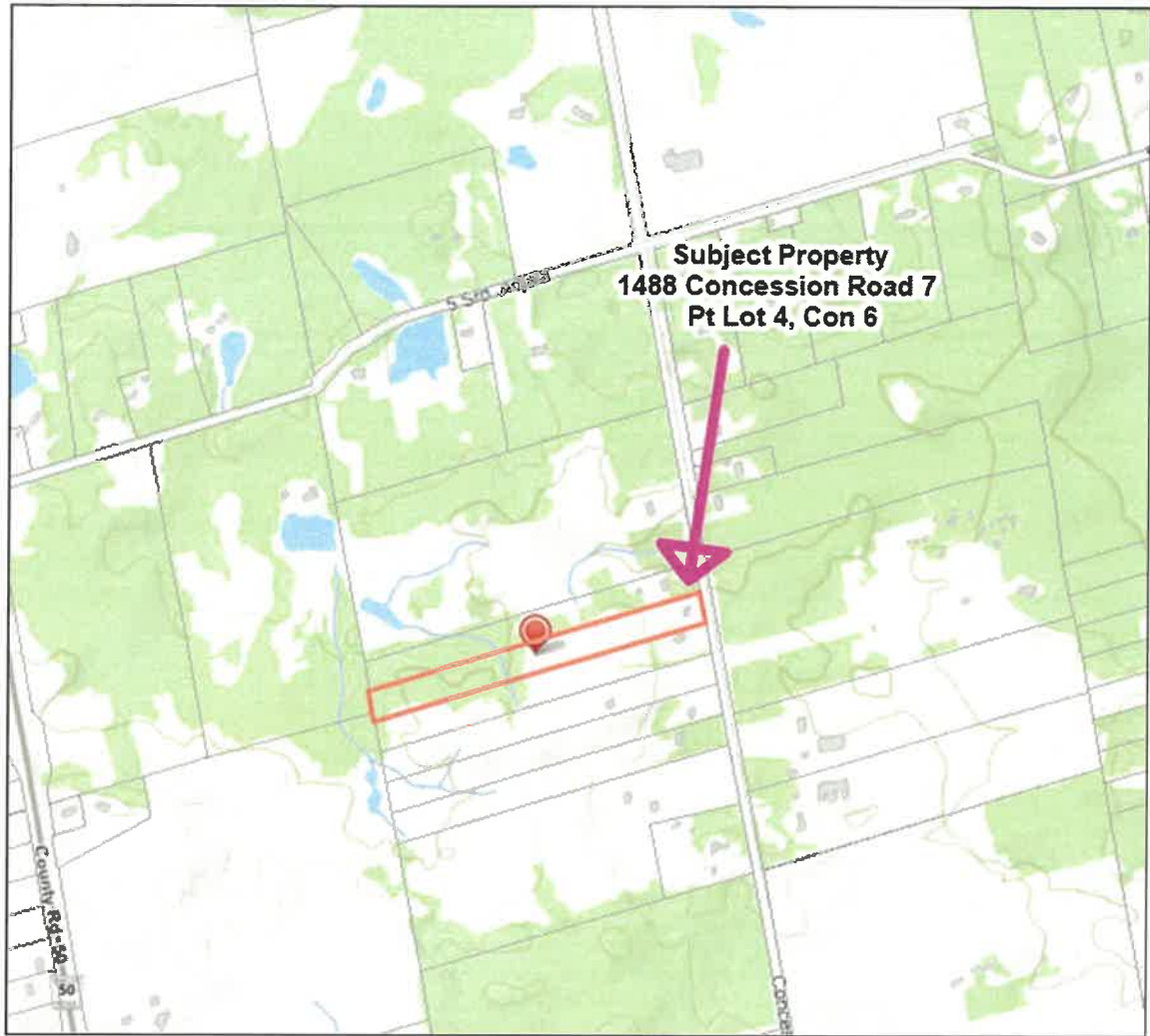

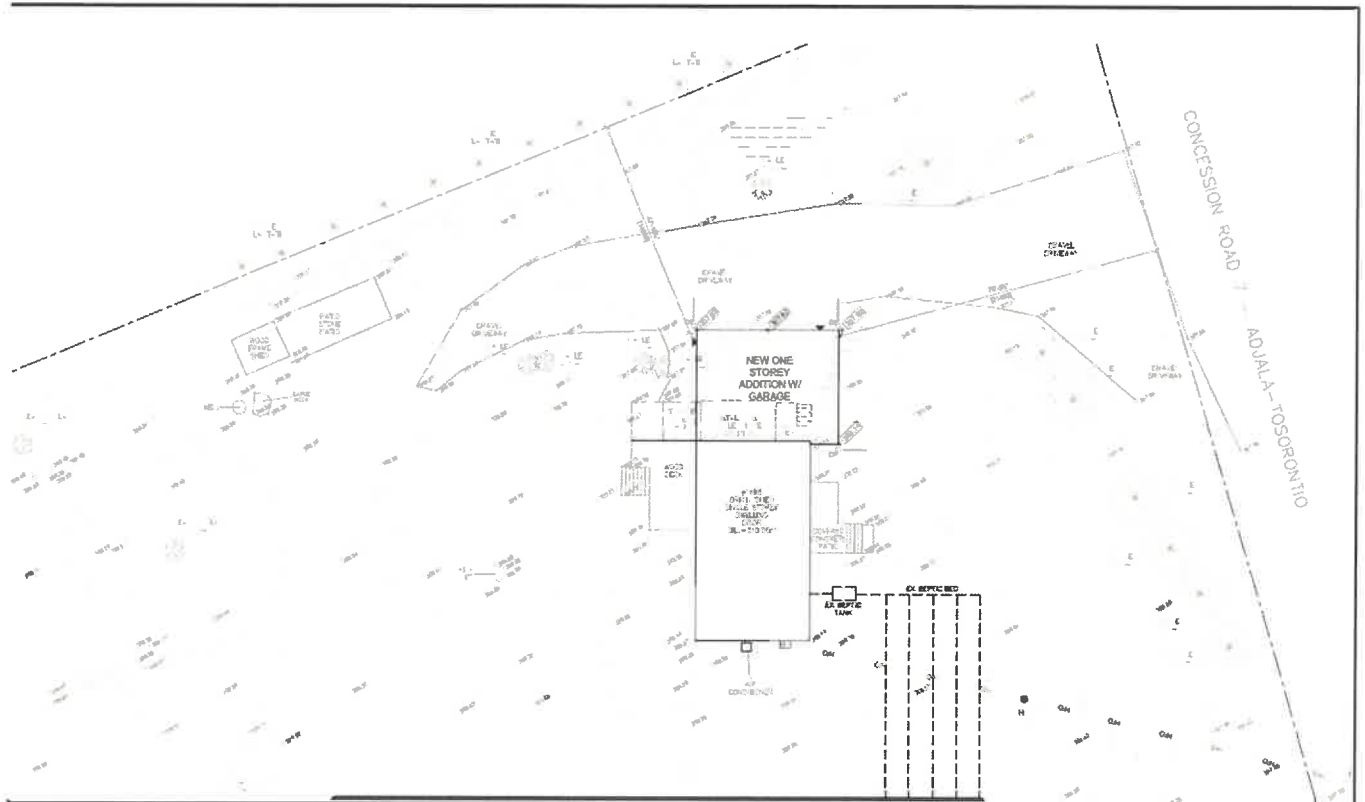
