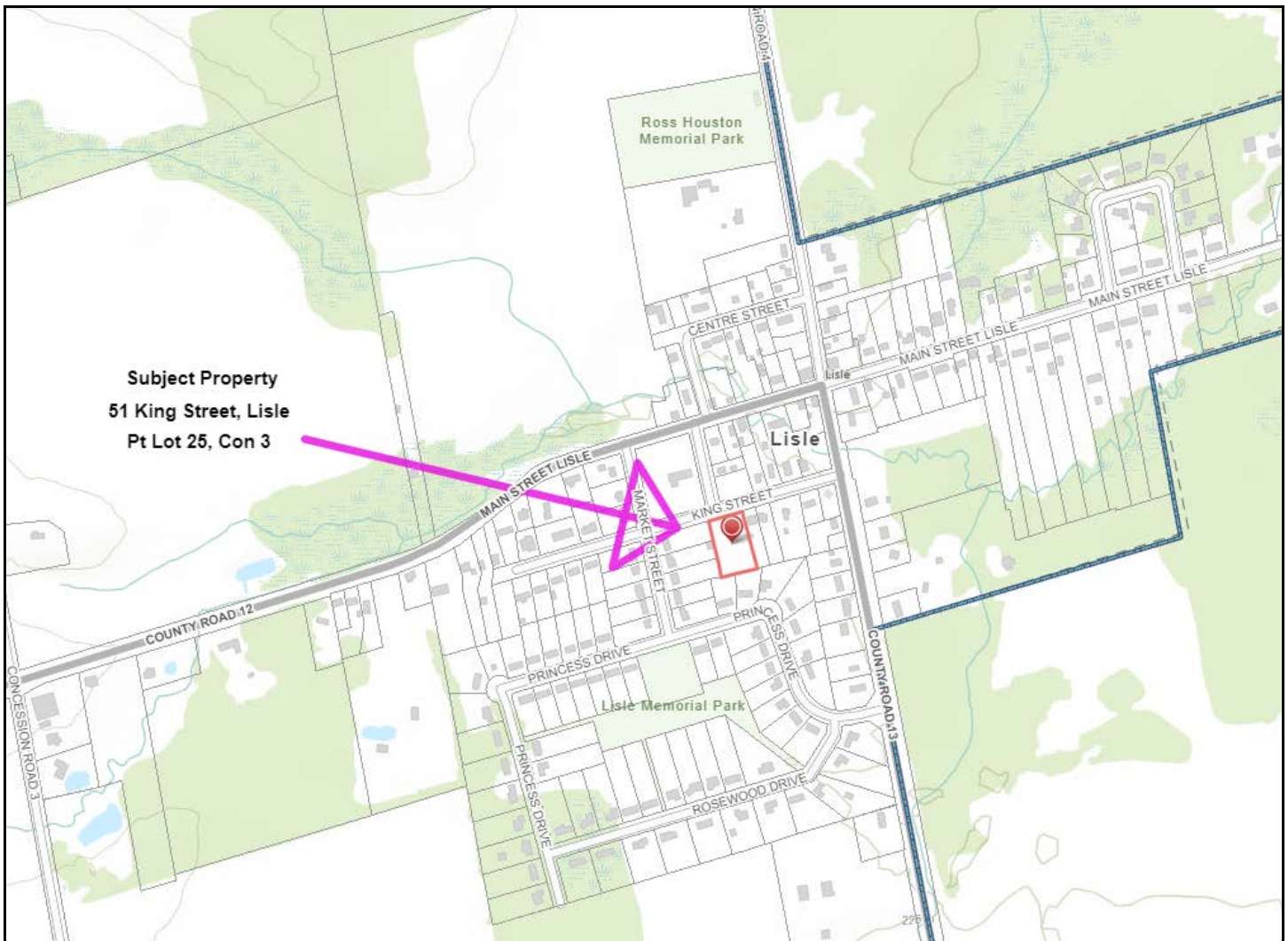
**If you wish to be notified of the decisions or a change to the conditions of the Committee of**

### **EXPLANATION OF THE PURPOSE AND EFFECT OF THE PROPOSED CONSENT Consent B/07/23 (Cox)**

An application has been made for consent under file number B/07/23 for consent to create a new residential lot on Pt Lot 25, Concession 3, Geographic Township of Tosorontio, Township of Adjala-Tosorontio (51 King Street, Lisle). The subject property has frontage of approximately 154.44m along King Street and an area of approximately 0.38ha. The proposed vacant severed lot will have approximately 21.94m frontage along King Street and an area of approximately 0.17ha. The proposed developed retained lot will have approximately 24.89m frontage along King Street and an area of approximately 0.21ha.
