If you do not attend at the hearing it may proceed in your absence and, except as otherwise provided in the Planning Act, you will not be entitled to any further notice in the proceedings.

**If you wish to be notified of the decisions or a change to the conditions of the Committee of Adjustment for the Township of Adjala-Tosorontio in respect of the proposed concurrent consent and minor variance, you must make a written request to the Committee of Adjustment at the above noted address.** If a person or public body that files an appeal of a decision of the Committee of Adjustment in respect of the proposed consent and/or minor variance and does not make an oral or written submission to the Committee of Adjustment before it gives or refuses to give a provisional consent, the Ontario Land Tribunal may dismiss the appeal.

**EXPLANATION OF THE PURPOSE AND EFFECT  
OF THE PROPOSED CONSENT  
Consent B/05/23 (Breedon)**

An application has been made for consent under file number B/05/23 for consent to recreate two agricultural lots on Pt Lot 23, Concession 3, Geographic Township of Adjala, Township of Adjala-Tosorontio (8642 20<sup>th</sup> Sideroad). The proposed severed property will have frontage of approximately 590.5m along 20<sup>th</sup> Sideroad, approximately 572m along Concession Road 4 and an area of approximately 39.2ha. The subject property has 428.08m frontage along Concession Road 3, approximately 1,246.2m along the 20<sup>th</sup> Sideroad, approximately 572m along Concession Road 4 and an area of approximately 76.3ha. The proposed retained lot will have approximately 428.08m frontage along Concession Road 3, approximately 655.7m along 20<sup>th</sup> Sideroad and an area of approximately 37.1ha.
