EXPLANATION OF THE PURPOSE AND EFFECT OF THE PROPOSED CONCURRENT CONSENT & MINOR VARIANCE B/02/20 & A/05/20 (Walmsley)

An application has been made under file number B/02/20 for consent to sever lands for a boundary line adjustment from Lot 8, Concession 6, Geographic Township of Tosorontio, Township of Adjala-Tosorontio (5826 Concession Road 6). The subject property is approximately 37.9ha in area with frontage of about 536m along Concession Road 6. The proposed vacant severed lands will have an area of approximately 35.4ha. and will be added to the vacant property located to the south. The developed retained lot will have frontage of about 158.6m on Concession Road 6 and is proposed to have an area of approximately 2.5ha. The resulting benefitting lot will have frontage of approximately 1,455m on Concession Road 6 and will have an approximate area of 87.4ha. Minor variance application A/05/20 is proposed to permit the retained Agricultural zoned property with a residential use to have a maximum area of 2.5ha where 1.0ha is allowed in Zoning By-law 03-57.
