# ZONING BY-LAW AMENDMENT APPLICATION Z/08/23

**TAKE NOTICE** that the Council of the Corporation of the Township of Adjala-Tosorontio has received applications under the Planning Act, R.S.O. 1990, as amended, for a Zoning By-law Amendment for property located on Part of Lot 25, Concession 5, geographic Township of Adjala, Township of Adjala-Tosorontio (8063 25<sup>th</sup> Sideroad.Adjala).

SYNOPSIS: To recognize the 10.3 metre setback for the detached accessory structure located in-front of the single-family dwelling and closer to the front property line, within the Agricultural (A) Zone.

**AND TAKE NOTICE** the Council of the Corporation of the Township of Adjala-Tosorontio will hold a **Hybrid Public Meeting on Wednesday**, **January 10<sup>th</sup>,2024**, **with the open session starting at 6:30 p.m.** 

There will be a commenting period from December 20, 2023 to January 5, 2024 on the mentioned reports in such a way that the public can participate by attending or sending their comments through letters, faxes, emails, voice messages, video clips or by registering with the Clerk's Department, to speak at the public meeting. Comments received after the commenting period will not be placed on the agenda, however they will be received by the Clerk's Department, <a href="mailto:clerk@adjtos.ca">clerk@adjtos.ca</a>, and kept on record with the application.

**AND TAKE NOTICE** that these meetings will be live streamed by the municipality through our iCompass portal.

If a person or public body would otherwise have an ability to appeal the decision of the Council of the Township of Adjala-Tosorontio to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the Township of Adjala-Tosorontio before the by-law is passed, the person or public body is not entitled to appeal the decision.

If a person or public body does not make oral submissions at a public meeting or make written submissions to the Township of Adjala-Tosorontio before the by-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.



# EXPLANATION OF THE PURPOSE AND EFFECT OF THE PROPOSED ZONING AMENDMENT Z/08/23 (8063 25th Sideroad, Adjala)


Application has been made for rezoning (Z/08/23) on lands located on Part of Lot 25, Concession 5, geographic township of Adjala, Township of Adjala-Tosorontio. The proposal is to amend the zoning of the property to recognize the 10.3 metre setback for the detached accessory structure located in-front of the single-family dwelling and closer to the front property line, within the Agricultural (A) Zone.

## By-law No. 24- XX

**Whereas** Zoning By-law No. 03-57, as amended, was further amended on May 10<sup>th</sup>, 2023 by By-law 2023-46 being a By-law to amend Zoning By-law 03-57, as amended, of the Township of Adjala-Tosorontio on Part of Lot 25, Concession 5, on Reference Plan 51 R24047 Part 1 & 2, RP 51R24140 Parts 1 & 2, geographic Township of Adjala, 8063 25th Sideroad (4301-010-003-03720);

**AND WHEREAS** it is deemed necessary and desirable to further amend By-law No. 23-46;

**AND WHEREAS** this amendment will conform to the Official Plan of the Township of Adjala-Tosorontio;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF ADJALA-TOSORONTIO ENACTS AS FOLLOWS:

- 1. **THAT** Section 2 ii. of By-law 2023-46 be amended by deleting 15.0 metres and replacing it with 10.3 metres.
- 2. **THAT** All other provisions of By-law 23-46 shall apply.

**THAT** this By-law shall come into force on the date of passage and take effect the day after the last date for filing a notice of appeal, where no notice of appeal is received, or, where a notice of appeal is received, upon the approval of the Ontario Land Tribunal, and in either case, in accordance with the provisions of the Planning Act, R.S.O. 1990, Ch. P. 13, as amended.
