**TAKE NOTICE** that the Council of the Corporation of the Township of Adjala-Tosorontio has received applications under the Planning Act, R.S.O. 1990, as amended, for a Zoning By-law Amendment for property located on Part of Lot 15, Concession 4, geographic Township of Adjala, Township of Adjala-Tosorontio (2762 Concession Road 5).

**SYNOPSIS: To permit construction of an accessory dwelling unit within the Oak Ridges Moraine Countryside (ORM CS) Zone.**

**AND TAKE NOTICE** that considering the restrictions due to COVID-19, the Council of the Corporation of the Township of Adjala-Tosorontio will hold a **Hybrid Public Meeting on Wednesday, May 10<sup>th</sup>, 2023 at 6:00 p.m. at a Regular Council Meeting.**

**AND TAKE NOTICE** that these meetings will be live streamed by the municipality through our iCompass portal.

If a person or public body would otherwise have an ability to appeal the decision of the Council of the Township of Adjala-Tosorontio to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the Township of Adjala-Tosorontio before the by-law is passed, the person or public body is not entitled to appeal the decision.

If a person or public body does not make oral submissions at a public meeting or make written submissions to the Township of Adjala-Tosorontio before the by-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.

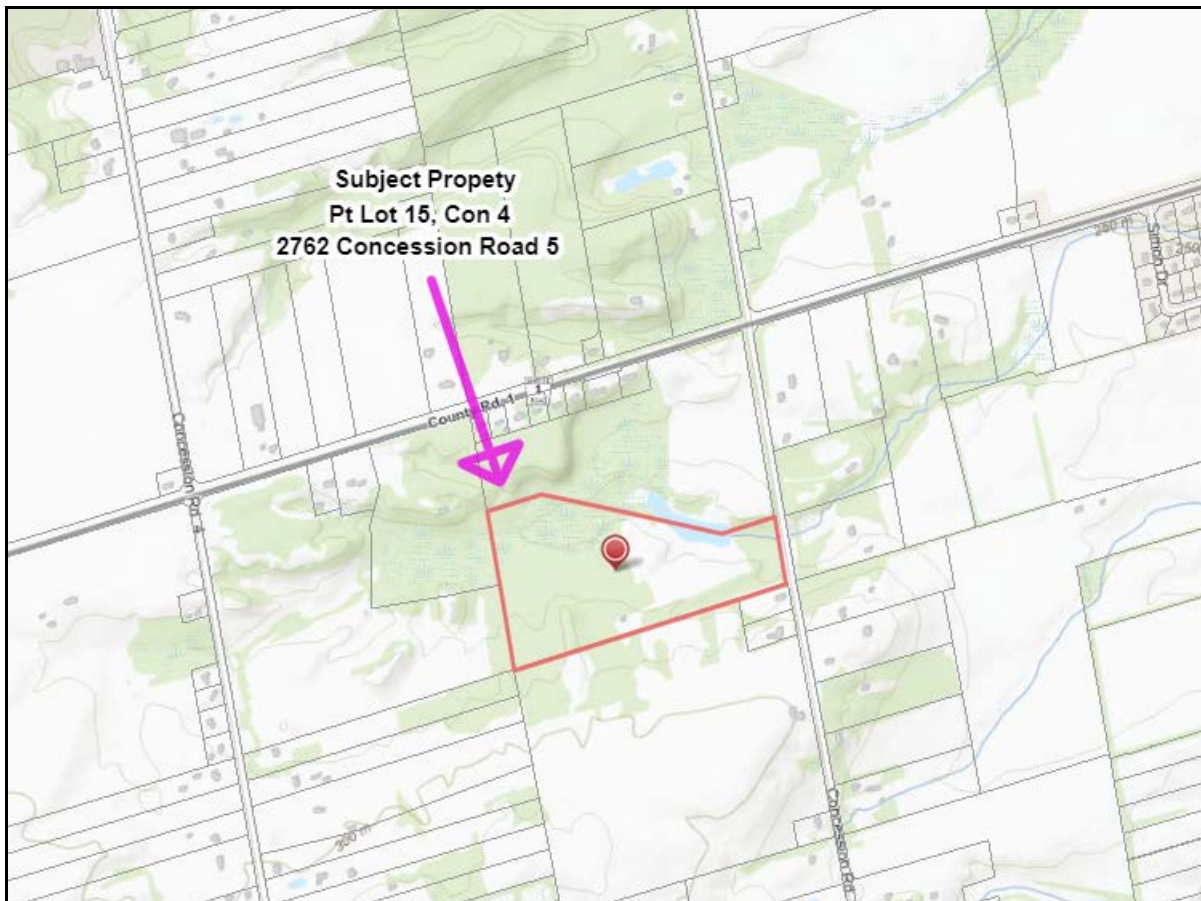

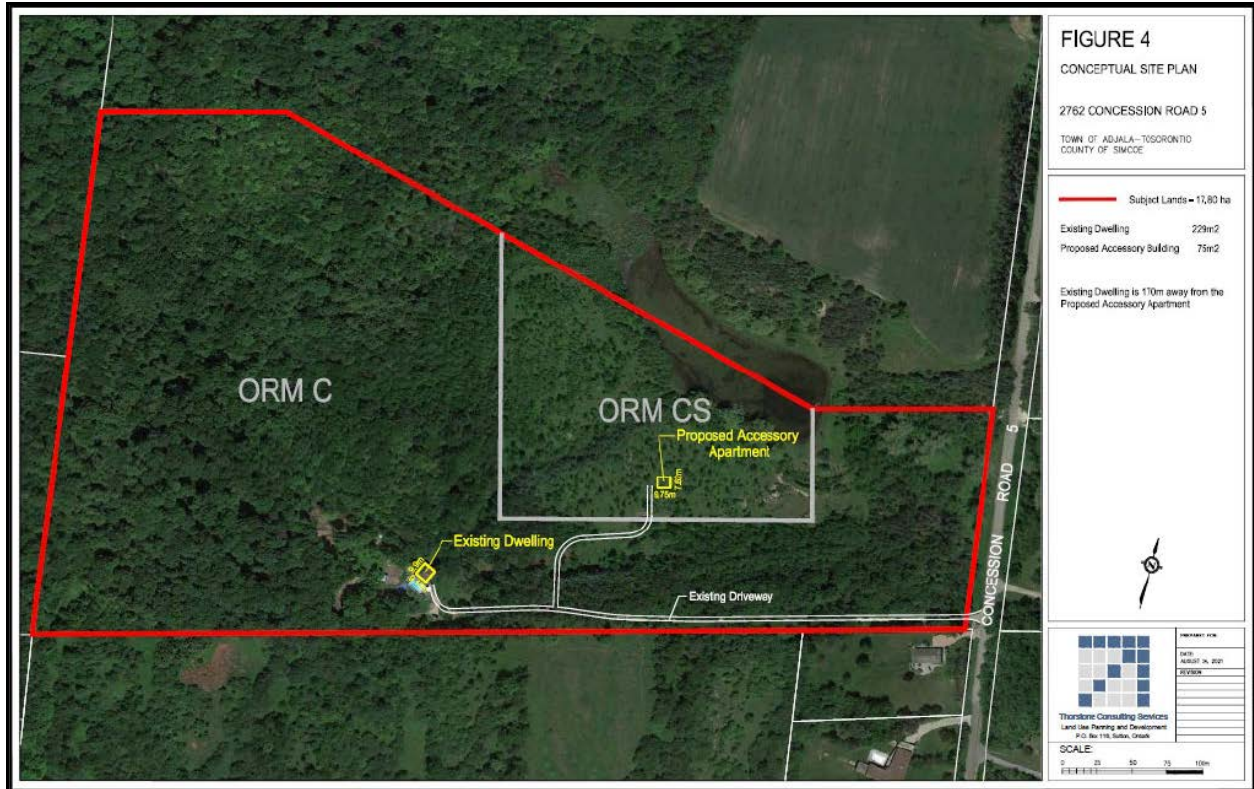

**EXPLANATION OF THE PURPOSE AND EFFECT  
OF THE PROPOSED ZONING AMENDMENT  
Z/10/23 (2762 Concession Road 5)**

Application has been made for rezoning (Z/10/23) on lands located on Part of Lot 15, Concession 4, geographic township of Adjala, Township of Adjala-Tosorontio. The proposal is to amend the zoning of the property to permit the construction of an accessory dwelling unit.

## By-law No. 23- XX

### A By-law to amend Zoning By-law 03-56, as amended, of the Township of Adjala-Tosorontio

---

#### Part of Lot 15, Concession 4, on Reference Plan 51R11143 Part 2, geographic Township of Adjala, 2762 Concession Road 5 (4301-010-002-02800)

**Whereas** Zoning By-law No. 03-56, as amended, constitutes the comprehensive Zoning By-law for the Township of Adjala-Tosorontio of those lands within the Oak Ridges Moraine area;

**Whereas** it is deemed necessary and desirable to further amend By-law No. 03-56, as amended;

**AND WHEREAS** this amendment will conform to the Official Plan of the Township of Adjala-Tosorontio;

**Now Therefore** the Council of The Corporation of The Township of Adjala-Tosorontio enacts as follows:

1. **THAT** Schedule "A-2" of By-law No. 03-56, as amended, is hereby further amended by changing the zoning on Part of Lot 15, Concession 4, geographic Township of Adjala, from Oak Ridges Moraine Conservation (ORMC) Zone and Oak Ridges Moraine Countryside (ORM CS) Zone to Oak Ridges Moraine Conservation (ORMC) Zone and Oak Ridges Moraine Countryside Exception 27 (ORM CS-27) Zone, as shown cross-hatched on Schedule "A", attached hereto.
2. **THAT** Section 14 – Site Specific Zone Exceptions for the Oak Ridges Moraine in By-law No. 03-56, as amended, is hereby further amended by adding the following:

#### **Section 14.27 (ORM CS-27 Zone)**

Schedule A-2, Part Lot 15, Con 4, geographic Township of Adjala.

Notwithstanding anything to the contrary found in this By-law, the zoning of lands described as Part of Lot 15, Concession 4 (geographic Township Adjala) is hereby further amended to permit the construction of an accessory dwelling unit.

Notwithstanding anything to the contrary found in this By-law, the following provisions shall apply to the lands Zoned Oak Ridges Moraine Countryside Exception 27 (ORM CS-27) Zone:

- i. That Section 13.1 be amended to include a permanent additional dwelling;
- ii. That notwithstanding Section 3.4e) of this By-law, the accessory dwelling shall be located in the front yard; and
- iii. That notwithstanding Section 3.4.i.i) of this By-law, the gross floor area of the accessory dwelling shall be 150 square metres (1,615 squared feet).

2. **THAT** Schedule "A" is hereby declared to form part of this By-law.

**THAT** this By-law shall come into force on the date of passage and take effect the day after the last date for filing a notice of appeal, where no notice of appeal is received, or, where a notice of appeal is received, upon the approval of the Ontario Land Tribunal, and in either case, in accordance with the provisions of the Planning Act, R.S.O. 1990, Ch. P. 13, as amended.

**THAT** notwithstanding anything contrary to the rules of procedure, this By-law having been introduced and read a first and second time and be considered read a third time and finally passed this \_\_\_\_\_ day of \_\_\_\_\_ 2023.

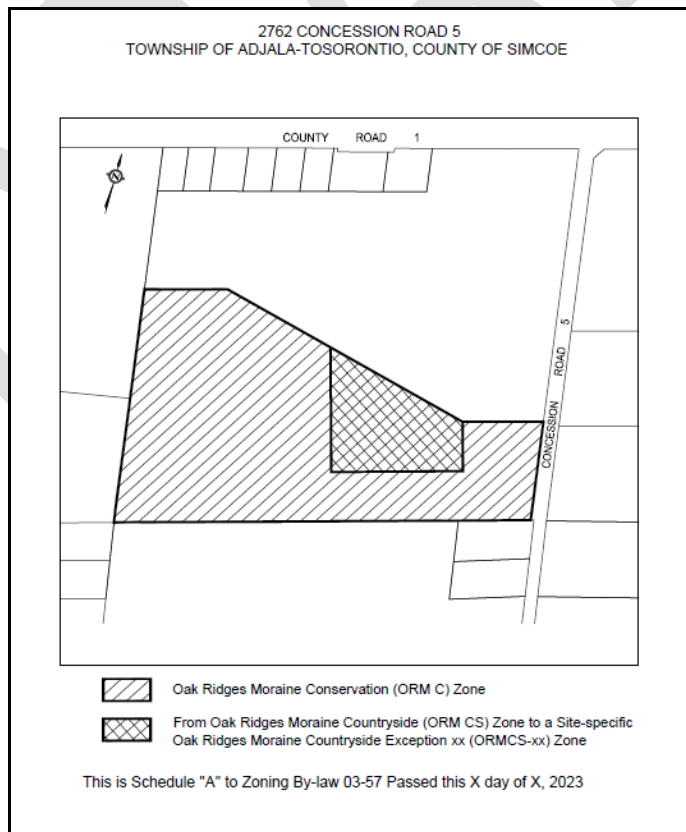
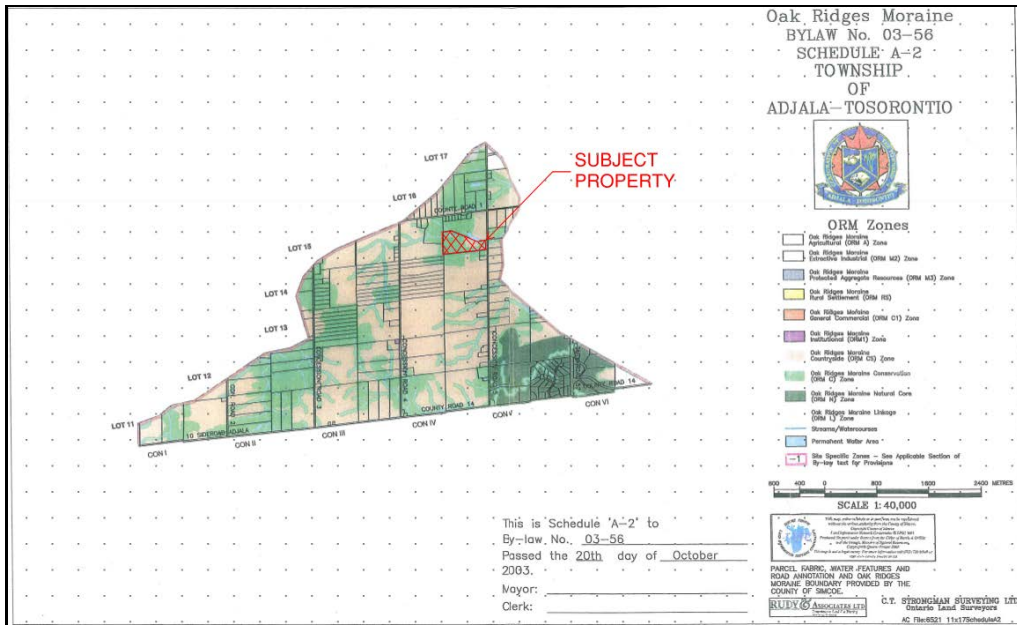
