TAKE NOTICE that the Council of the Corporation of the Township of Adjala-Tosorontio has received applications under the Planning Act, R.S.O. 1990, as amended, for a Zoning By-law Amendment for property located on Part of Lot 8, Concession 5, geographic Township of Tosorontio, Township of Adjala-Tosorontio (5767 County Road 13).

SYNOPSIS: To permit construction of an oversized detached accessory structure in front of the single-family dwelling in the Rural (R) Zone and to permit an inground pool within the Open Space Conservation (OSC) Zone.

AND TAKE NOTICE that considering the restrictions due to COVID-19, the Council of the Corporation of the Township of Adjala-Tosorontio will hold a **Hybrid Public Meeting on Wednesday, December 14th,2022 at 6:00 p.m. at a Regular Council Meeting.**

There will be a commenting period from November 16, 2022 to December 9, 2022 on the mentioned reports in such a way that the public can participate by attending or sending their comments through letters, faxes, emails, voice messages, video clips or by registering with the Clerk's Department, to speak at the public meeting. Comments received after the commenting period will not be placed on the agenda, however they will be received by the Clerk's Department, <u>clerk@adjtos.ca</u>, to be read at the meeting and kept on record with the application.

AND TAKE NOTICE that these meetings will be live streamed by the municipality through our iCompass portal.

If a person or public body would otherwise have an ability to appeal the decision of the Council of the Township of Adjala-Tosorontio to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the Township of Adjala-Tosorontio before the by-law is passed, the person or public body is not entitled to appeal the decision.

If a person or public body does not make oral submissions at a public meeting or make written submissions to the Township of Adjala-Tosorontio before the by-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.

EXPLANATION OF THE PURPOSE AND EFFECT OF THE PROPOSED ZONING AMENDMENT Z/17/22 (5767 County Road 13)

Application has been made for rezoning (Z/17/22) on lands located on Part of Lot 8, Concession 5, geographic township of Tosorontio, Township of Adjala-Tosorontio. The proposal is to amend the zoning of the property to permit construction of an oversized detached accessory structure in front of the single-family dwelling, with a maximum gross floor area of 190 square metres, in the Rural (R) Zone and to permit an inground pool within the Open Space Conservation (OSC) Zone. (Part Lot 8, Concession 5).

A By-law to amend Zoning By-law 03-57, as amended, of the Township of Adjala-Tosorontio

Part of Lot 8, Concession 5, on Reference Plan, geographic Township of Tosorontio, 5767 County Road 13 (4301-020-002-02300)

Whereas Zoning By-law No. 03-57, as amended, constitutes the comprehensive Zoning By-law for the Township of Adjala-Tosorontio save and except those lands within the Oak Ridges Moraine area;

AND WHEREAS it is deemed necessary and desirable to further amend By-law No. 03-57, as amended;

AND WHEREAS this amendment will conform to the Official Plan of the Township of Adjala-Tosorontio;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF ADJALA-TOSORONTIO ENACTS AS FOLLOWS:

- THAT Schedule "A-5" of By-law No. 03-57, as amended, is hereby further amended by changing the zoning on Part of Lot 8, Concession 5, geographic Township of Tosorontio, from Rural (R) & Open Space Conservation (OSC) zone to Rural Exception 118 (R-118) Zone & Open Space Conservation Exception 18 (OSC-18) Zone, as shown cross-hatched on Schedule "A", attached hereto.
- 2. **THAT** Section 5.4 Zone Exceptions for the Rural (R) Zone in By-law No. 03-57, as amended, is hereby further amended by adding the following:

Section 5.4.118 (R-118 Zone)

Schedule A-5, Part Lot 8, geographic Township of Tosorontio.

Notwithstanding anything to the contrary found in this By-law, the zoning of lands described as Part of Lot 8, Concession 5 (geographic Township Tosorontio) is hereby further amended to permit the construction of a detached accessory in front of the single-family dwelling.

Notwithstanding anything to the contrary found in this By-law, the following provisions shall apply to the accessory structure:

- i. No more than one (1) accessory structure shall be permitted in front of the single-family dwelling; and
- ii. The maximum gross floor area of the accessory structure shall be 190 square metres (2045 square feet).

All other provisions of the Rural (R) Zone shall apply.

3. THAT Section 15.3 – Zone Exceptions for the Open Space Conservation (OSC) Zone in By-law 03-57, as amended, is hereby further amended by adding the following:

Section 15.3.18 (OSC-18 Zone)

Schedule A-5, Part Lot 8, geographic Township of Tosorontio.

Notwithstanding anything to the contrary found in this By-law, the zoning of lands described as Part of Lot 8, Concession 5 (geographic Township Tosorontio) is hereby further amended to permit the existing inground pool and the construction of a detached accessory.

2. **THAT** Schedule "A" is hereby declared to form part of this By-law.

THAT this By-law shall come into force on the date of passage and take effect the day after the last date for filing a notice of appeal, where no notice of appeal is received, or, where a notice of appeal is received, upon the approval of the Ontario Land Tribunal, and in either case, in accordance with the provisions of the Planning Act, R.S.O. 1990, Ch. P. 13, as amended.

THAT notwithstanding anything contrary to the rules of procedure, this By-law having been introduced and read a first and second time and be considered read a third time and finally passed this _____ day of _____ 2022.
