**NOTICE OF PASSING OF ZONING BY-LAW**

Township of Adjala-Tosorontio**

**TAKE NOTICE** that the Council of the Corporation of the Township of Adjala-Tosorontio passed **By-law No. 23-99** on **December 13<sup>th</sup>, 2023** under section 34 of the Planning Act, R.S.O. 1990, Chapter P.13, as amended.

**AND TAKE NOTICE** that any person or agency may appeal to the Ontario Land Tribunal (OLT) in respect of the By-law by filing with the Clerk of the Corporation of the Township of Adjala-Tosorontio, not later than the

**4<sup>th</sup> DAY OF JANUARY 2024**

a Notice of Appeal setting out the objection to the By-law and the reasons in support of the objection, to be accompanied by the required fee to the OLT (\$1,100.00 cheque or money order payable to the Minister of Finance or the private citizen fee with the request for "Lower Fee Form").

**The purpose and effect of the By-law is to permit an accessory dwelling unit within the existing single-family dwelling, within the Hamlet Residential One (HR1) Zone.**

The following information is attached with this notice:

- A copy of the Zoning Amendment By-law; and,
- A map showing the location of the lands to which the By-law applies.

For further information, please contact the Municipal Office during regular office hours.

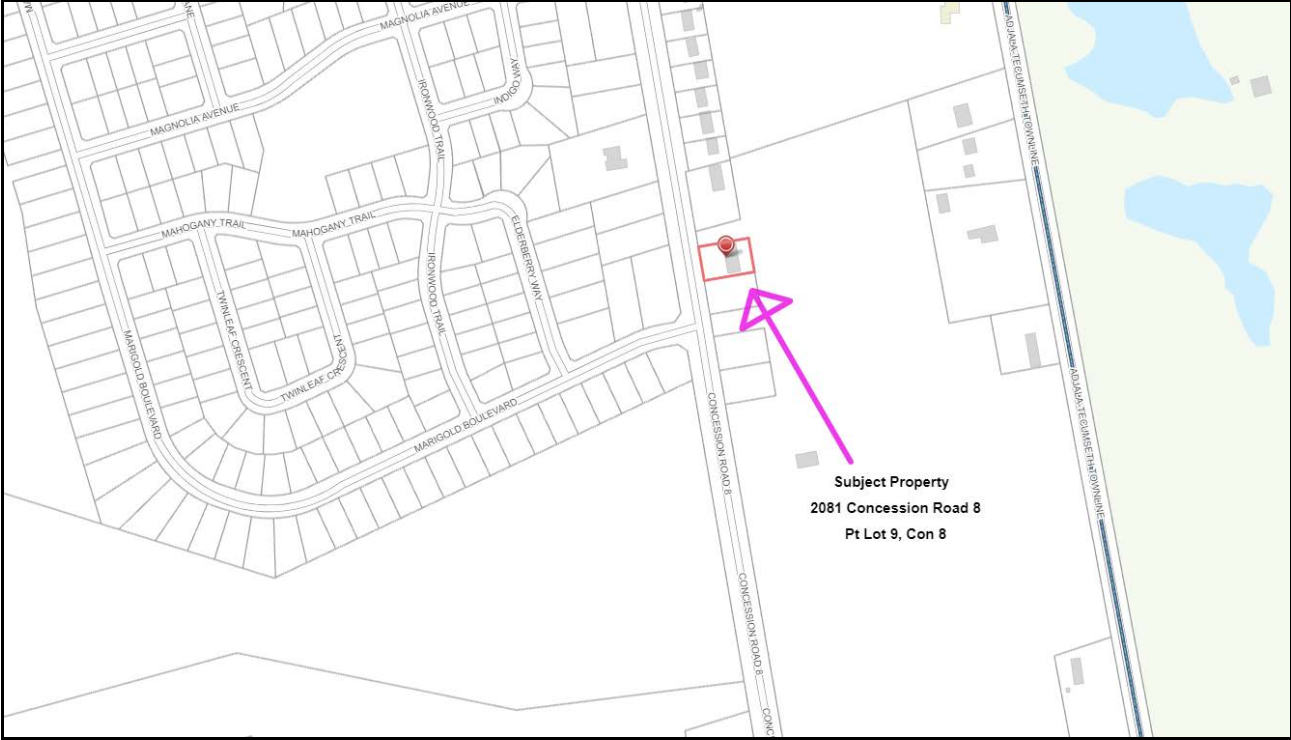
Only individuals, corporations and public bodies may appeal a by-law to the OLT. A notice of appeal may not be filed by an unincorporated association or group however, a notice of appeal may be filed in the name of an individual who is a member of the association or the group on its behalf.

No person or public body shall be added as a party to the hearing of the appeal unless, before the by-law was passed, the person or public body made oral submissions at a public meeting or written submissions to the council or, in the opinion of the OLT, there are reasonable grounds to add the person or public body as a party.

**By-Law No. 2023-99**

**A By-law to amend Zoning By-law 03-57, as amended, of the Township of Adjala-Tosorontio on Part of Lot 9, Concession 8, on Reference Plan 51R38996 Part 1, geographic Township of Adjala, 2081 Concession Road 8 (4301-010-001-20606)**

**WHEREAS** Zoning By-law No. 03-57, as amended, constitutes the comprehensive Zoning By-law for the Township of Adjala-Tosorontio save and except those lands within the Oak Ridges Moraine area;

**AND WHEREAS** it is deemed necessary and desirable to further amend By-law No. 03-57, as amended;

**AND WHEREAS** this amendment will conform to the Official Plan of the Township of Adjala-Tosorontio;

**NOW THEREFORE** the Council of Township of Adjala-Tosorontio hereby **ENACTS AS FOLLOWS:**

1. THAT Schedule "B-1" of By-law No. 03-57, as amended, is hereby further amended by changing the zoning on Part of Lot 9, Concession 8, geographic Township of Adjala, from Hamlet Residential One (HR1) Zone to Hamlet Residential One Exception 36 (HR1-36) Zone, as shown cross-hatched on Schedule "A", attached hereto.
2. THAT Section 18.3 – Zone Exceptions for the Hamlet Residential One (HR1) Zone in By-law No. 03-57, as amended, is hereby further amended by adding the following:

**Section 18.3.36 (HR1-36 Zone)**

Schedule B-1, Part Lot 9, Con 8, geographic Township of Adjala

Notwithstanding anything to the contrary found in this By-law, the zoning of lands described as Part of Lot 9, Concession 8 (geographic Township Adjala) is hereby further amended to permit an accessory dwelling unit within the existing single-family dwelling.

Notwithstanding anything to the contrary found in this By-law, the following provisions shall apply to the lands:

- i. That only one (1) accessory dwelling unit shall be permitted.

All other provisions of the Hamlet Residential One (HR1) Zone shall apply.

3. THAT Schedule "A" and "B" are hereby declared to form part of this By-law.

#### **ENACTMENT**

**THAT** this By-law shall come into force on the date of passage and take effect the day after the last date for filing a notice of appeal, where no notice of appeal is received, or, where a notice of appeal is received, upon the approval of the Ontario Land Tribunal, and in either case, in accordance with the provisions of the Planning Act, R.S.O. 1990, Ch. P. 13, as amended.

**THAT** notwithstanding anything contrary to the rules of procedure, this By-law be introduced and read a first and second time and be considered read a third time and finally passed this 13th day of December, 2023.

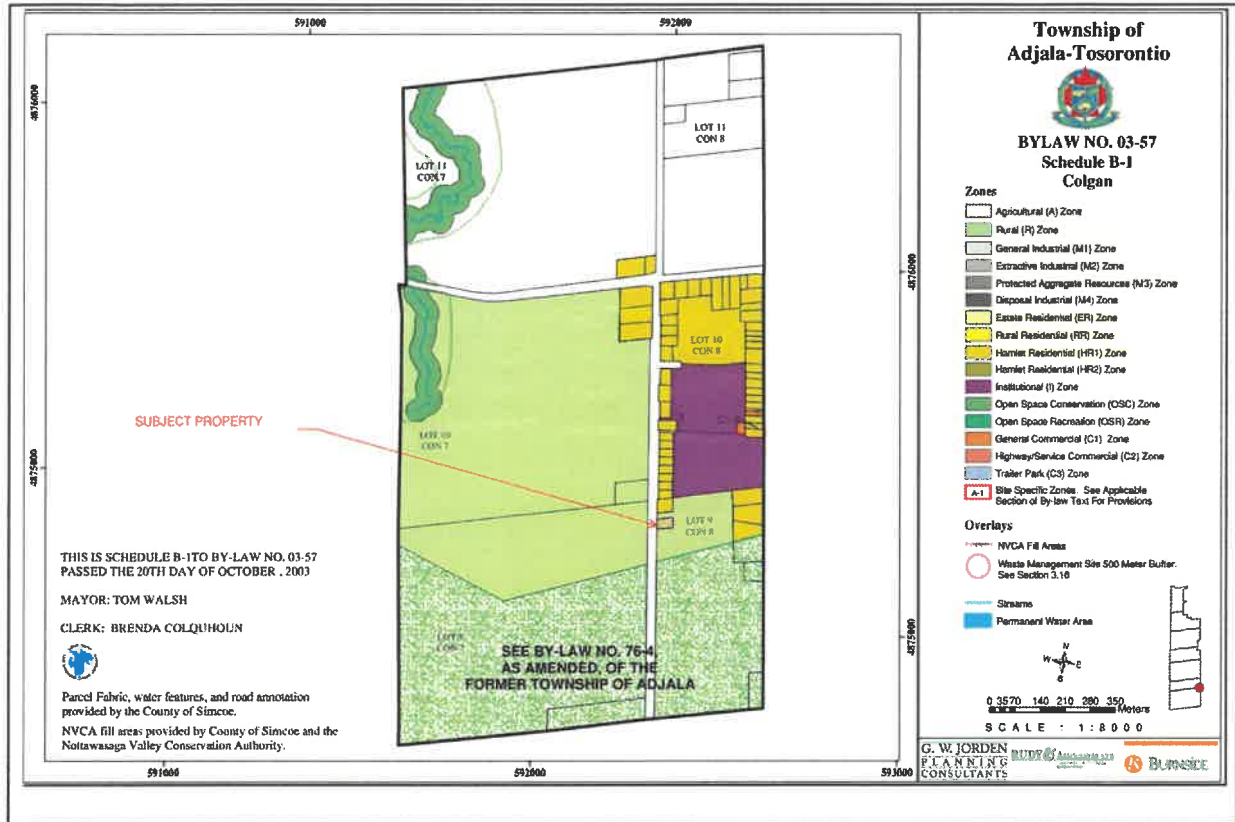
