Only individuals, corporations and public bodies may appeal a by-law to the OLT. A notice of appeal may not be filed by an unincorporated association or group however, a notice of appeal may be filed in the name of an individual who is a member of the association or the group on its behalf.

No person or public body shall be added as a party to the hearing of the appeal unless, before the by-law was passed, the person or public body made oral submissions at a public meeting or written submissions to the council or, in the opinion of the OLT, there are reasonable grounds to add the person or public body as a party.

A By-law to amend By-law 18-59, being a by-law to amend By-law 08-23, being a by-law to amend Zoning By-law 03-57, as amended, of the Township of Adjala-Tosorontio

Part of Lot 13, Concession 6, 51R25888 Part 1 on Reference Plan, geographic Township of Adjala, 2535 County Road 50 (4301-010-002-09800)

Whereas the Council of the Corporation of the Township of Adjala-Tosorontio passed By-law 18-59 to amend by-law 08-23, to amend By-law 03-57, as amended, on September 10th, 2018, to extend the powers under By-law 08-23 under Section 39 of the Planning Act,

AND WHEREAS By-law 18-59 expired on August 17th, 2021 at 11:59 p.m.

AND WHEREAS the Owners of the property have requested to make the structure permanent in By-law 18-59

AND WHEREAS it is deemed necessary and desirable to further amend By-law No. 18-59

AND WHEREAS this amendment will conform to the Official Plan of the Township of Adjala-Tosorontio

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF ADJALA-TOSORONTIO ENACTS AS FOLLOWS:

1. **THAT** Section 5.4.30 – Zone Exceptions for the Rural Exception Thirty (R-30) Zone in By-law No. 03-57, as amended, is hereby further amended by adding the following:

Section 5.4.30 (R-30 Zone)

Schedule A-2, Part of Lot 13, Concession 6, geographic Township of Adjala.

Notwithstanding any provisions to the contrary of this By-law, the following altered and additional provisions shall apply to the lands zoned **R-30**:

i. No more than one (1) permanent accessory apartment shall be permitted upon entrance permit approvals from the County of Simcoe, in the R-30 zone

2. **THAT** Section 5.4.30 – Zone Exceptions for the Rural Exception Thirty (R-30) Zone in By-law No. 03-57, as amended, is hereby further amended by removing the following:

Section 5.4.30 (R-30 Zone)

Schedule A-2, Part of Lot 13, Concession 6, geographic Township of Adjala.

Notwithstanding any provisions to the contrary of this By-law, the following provisions shall be removed to the lands zoned **R-30**:

i. That the Temporary Use of a garden suite shall be removed

All other provisions of the Rural (R) zone continue to apply.

3. **THAT** Schedule "A" is hereby declared to form part of this By-law.

THAT this By-law shall come into force on the date of passage and take effect the day after the last date for filing a notice of appeal, where no notice of appeal is received, or, where a notice of appeal is received, upon the approval of the Local Planning Appeal Tribunal, and in either case, in accordance with the provisions of the Planning Act, R.S.O. 1990, Ch. P. 13, as amended.

THAT notwithstanding anything contrary to the rules of procedure, this By-law having been introduced and read a first and second time and be considered read a third time and finally passed this 9th day of February 2022.
