NOTICE OF PASSING OF ZONING BY-LAW

**Part of Lot 5, Concession 7
7553 5th Sideroad
Geographic Township of Tosorontio
Township of Adjala-Tosorontio**

TAKE NOTICE that the Council of the Corporation of the Township of Adjala-Tosorontio passed **By-law No. 22-63** on **June 8th, 2022** under section 34 of the Planning Act, R.S.O. 1990, Chapter P.13, as amended.

AND TAKE NOTICE that any person or agency may appeal to the Ontario Land Tribunal (OLT) in respect of the By-law by filing with the Clerk of the Corporation of the Township of Adjala-Tosorontio, not later than the

4th DAY OF JULY 2022

a Notice of Appeal setting out the objection to the By-law and the reasons in support of the objection, to be accompanied by the required fee to the OLT (\$1,100.00 cheque or money order payable to the Minister of Finance or the private citizen fee with the request for "Lower Fee Form").

The purpose and effect of the By-law is to permit an addition to an existing detached accessory structure in front of the single-family dwelling.

The following information is attached with this notice:

- A copy of the Zoning Amendment By-law; and,
- A map showing the location of the lands to which the By-law applies.

For further information, please contact the Municipal Office during regular office hours.

Only individuals, corporations and public bodies may appeal a by-law to the OLT. A notice of appeal may not be filed by an unincorporated association or group however, a notice of appeal may be filed in the name of an individual who is a member of the association or the group on its behalf.

No person or public body shall be added as a party to the hearing of the appeal unless, before the by-law was passed, the person or public body made oral submissions at a public meeting or written submissions to the council or, in the opinion of the OLT, there are reasonable grounds to add the person or public body as a party.

By-law No. 22- 63

A By-law to amend Zoning By-law 03-57, as amended, of the Township of Adjala-Tosorontio

Part of Lot 5, Concession 7, Plan M129 Lot 9 on Reference Plan, geographic Township of Tosorontio, 7553 5th Sideroad (4301-020-002-100-09)

Whereas Zoning By-law No. 03-57, as amended, constitutes the comprehensive Zoning By-law for the Township of Adjala-Tosorontio save and except those lands within the Oak Ridges Moraine area;

AND WHEREAS it is deemed necessary and desirable to further amend By-law No. 03-57, as amended;

AND WHEREAS this amendment will conform to the Official Plan of the Township of Adjala-Tosorontio;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF ADJALA-TOSORONTIO ENACTS AS FOLLOWS:

1. **THAT** Schedule "A-5" of By-law No. 03-57, as amended, is hereby further amended by changing the zoning on Part of Lot 5, Concession 7, geographic Township of Tosorontio, from Estate Residential Exception Twelve (ER-12) Zone to Estate Residential Exception Twenty-Seven (ER-27) Zone, as shown cross-hatched on Schedule "A", attached hereto.
2. **THAT** Section 17.4 – Zone Exceptions for the Estate Residential Zone in By-law No. 03-57, as amended, is hereby further amended by adding the following:
3. Section 17.4.27 (ER-27 Zone)

Schedule A-5, Part Lot 5, geographic Township of Tosorontio

Notwithstanding anything to the contrary found in this By-law, the zoning of lands described as Part of Lot 5, Concession 7, M129 Lot 9 (geographic Township of Tosorontio) is hereby further amended to permit the construction of an addition to an existing detached accessory structure, in front of the single-family dwelling.

Notwithstanding anything to the contrary found in this By-law, the following provisions shall apply to the detached accessory structure:

- i. The addition to the existing detached accessory structure shall be permitted in front of the single-family dwelling; and
- ii. Shall have a minimum front yard setback of 25 metres.

2. **THAT** Schedule "A" is hereby declared to form part of this By-law.

THAT this By-law shall come into force on the date of passage and take effect the day after the last date for filing a notice of appeal, where no notice of appeal is received, or, where a notice of appeal is received, upon the approval of the Ontario Land Tribunal, and in either case, in accordance with the provisions of the Planning Act, R.S.O. 1990, Ch. P. 13, as amended.

THAT notwithstanding anything contrary to the rules of procedure, this By-law having been introduced and read a first and second time and be considered read a third time and finally passed this 8th day of June 2022.
