NOTICE OF PASSING OF ZONING BY-LAW

**Part of Lot 8, Concession 5
5767 County Road 13
Geographic Township of Tosorontio
Township of Adjala-Tosorontio**

TAKE NOTICE that the Council of the Corporation of the Township of Adjala-Tosorontio passed **By-law No. 23-07** on **January 11th, 2023** under section 34 of the Planning Act, R.S.O. 1990, Chapter P.13, as amended.

AND TAKE NOTICE that any person or agency may appeal to the Ontario Land Tribunal (OLT) in respect of the By-law by filing with the Clerk of the Corporation of the Township of Adjala-Tosorontio, not later than the

2nd DAY OF FEBRUARY 2023

a Notice of Appeal setting out the objection to the By-law and the reasons in support of the objection, to be accompanied by the required fee to the OLT (\$1,100.00 cheque or money order payable to the Minister of Finance or the private citizen fee with the request for "Lower Fee Form").

The purpose and effect of the By-law is to permit construction of an oversized detached accessory structure located in front of the single-family dwelling in the Rural (R) Zone and to permit an inground pool within the Open Space Conservation (OSC) Zone.

The following information is attached with this notice:

- A copy of the Zoning Amendment By-law; and,
- A map showing the location of the lands to which the By-law applies.

For further information, please contact the Municipal Office during regular office hours.

Only individuals, corporations and public bodies may appeal a by-law to the OLT. A notice of appeal may not be filed by an unincorporated association or group however, a notice of appeal may be filed in the name of an individual who is a member of the association or the group on its behalf.



No person or public body shall be added as a party to the hearing of the appeal unless, before the by-law was passed, the person or public body made oral submissions at a public meeting or written submissions to the council or, in the opinion of the OLT, there are reasonable grounds to add the person or public body as a party.

By-law No. 23- 07

A By-law to amend Zoning By-law 03-57, as amended, of the Township of Adjala-Tosorontio

Part of Lot 8, Concession 5, on Reference Plan, geographic Township of Tosorontio, 5767 County Road 13 (4301-020-002-02300)

Whereas Zoning By-law No. 03-57, as amended, constitutes the comprehensive Zoning By-law for the Township of Adjala-Tosorontio save and except those lands within the Oak Ridges Moraine area;

AND WHEREAS it is deemed necessary and desirable to further amend By-law No. 03-57, as amended;

AND WHEREAS this amendment will conform to the Official Plan of the Township of Adjala-Tosorontio;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF ADJALA-TOSORONTIO ENACTS AS FOLLOWS:

1. **THAT** Schedule "A-5" of By-law No. 03-57, as amended, is hereby further amended by changing the zoning on Part of Lot 8, Concession 5, geographic Township of Tosorontio, from Rural (R) & Open Space Conservation (OSC) zone to Rural Exception 118 (R-118) Zone & Open Space Conservation Exception 18 (OSC-18) Zone, as shown cross-hatched on Schedule "A", attached hereto.
2. **THAT** Section 5.4 – Zone Exceptions for the Rural (R) Zone in By-law No. 03-57, as amended, is hereby further amended by adding the following:

Section 5.4.118 (R-118 Zone)

Schedule A-5, Part Lot 8, geographic Township of Tosorontio.

Notwithstanding anything to the contrary found in this By-law, the zoning of lands described as Part of Lot 8, Concession 5 (geographic Township Tosorontio) is hereby further amended to permit the construction of a detached accessory in front of the single-family dwelling.

Notwithstanding anything to the contrary found in this By-law, the following provisions shall apply to the accessory structure:

- i. No more than one (1) accessory structure shall be permitted in front of the single-family dwelling; and
- ii. The maximum gross floor area of the accessory structure shall be 190 square metres (2045 square feet).

All other provisions of the Rural (R) Zone shall apply.

3. THAT Section 15.3 – Zone Exceptions for the Open Space Conservation (OSC) Zone in By-law 03-57, as amended, is hereby further amended by adding the following:

Section 15.3.18 (OSC-18 Zone)

Schedule A-5, Part Lot 8, geographic Township of Tosorontio.

Notwithstanding anything to the contrary found in this By-law, the zoning of lands described as Part of Lot 8, Concession 5 (geographic Township Tosorontio) is hereby further amended to permit the existing inground pool and the construction of a detached accessory.

2. **THAT** Schedule “A” is hereby declared to form part of this By-law.

THAT this By-law shall come into force on the date of passage and take effect the day after the last date for filing a notice of appeal, where no notice of appeal is received, or, where a notice of appeal is received, upon the approval of the Ontario Land Tribunal, and in either case, in accordance with the provisions of the Planning Act, R.S.O. 1990, Ch. P. 13, as amended.

THAT notwithstanding anything contrary to the rules of procedure, this By-law having been introduced and read a first and second time and be considered read a third time and finally passed this 11th day of January 2023.

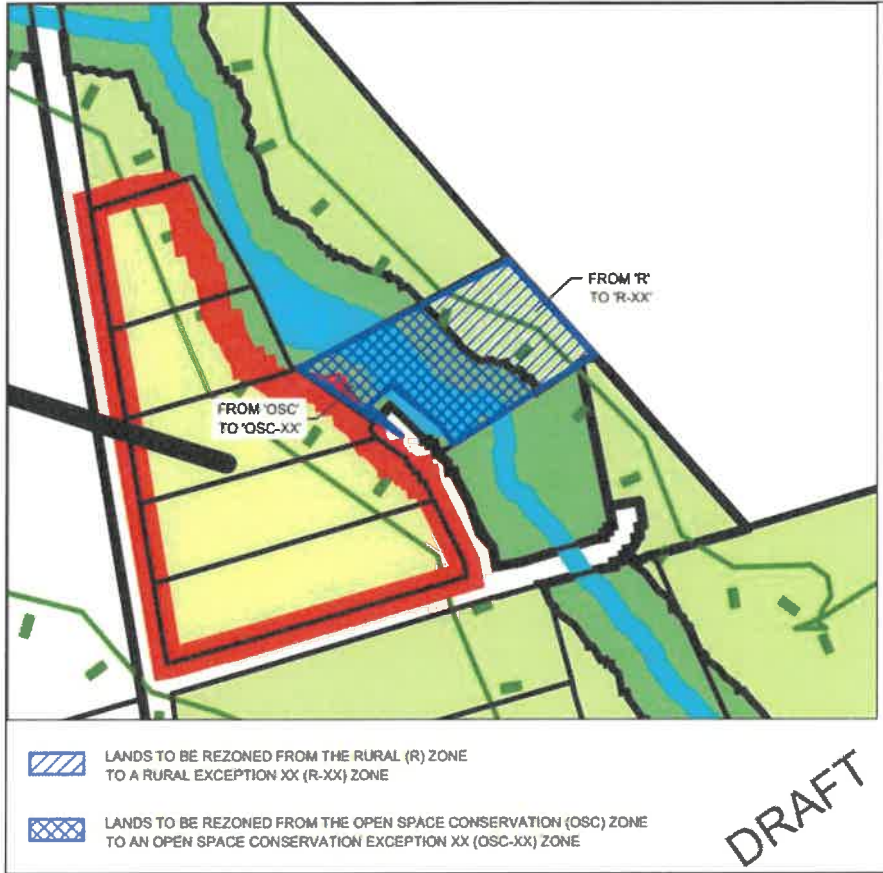
