If you wish to be notified of the decision or a change to the conditions of the Committee of Adjustment for the Township of Adjala-Tosorontio in respect of the proposed consent, you must make a written request to the Committee of Adjustment at the above noted address. If a person or public body that files an appeal of a decision of the Committee of Adjustment in respect of the proposed consent and does not make an oral or written submission to the Committee of Adjustment before it gives or refuses to give a provisional consent, the Local Planning Appeal Tribunal may dismiss the appeal.

**EXPLANATION OF THE PURPOSE AND EFFECT
OF THE PROPOSED CONSENT
Consent B/05/21 (Storey)**

An Application has been made for consent under file number B/05/21 for consent to sever lands for a surplus dwelling as a result of a farm consolidation from Pt Lot 5, Concession 6, Geographic Township of Tosorontio, Township of Adjala-Tosorontio (5445 Concession Road 6). The subject property has frontage of approximately 475m along Concession Road 6, frontage of approximately 544m along 5th Sideroad and an area of approximately 38ha. The proposed developed severed lot will have 60m frontage along Concession Road 6 and an area of approximately 0.48ha. The proposed vacant retained lot will have approximately 415m frontage along Concession Road 6, approximately 544m frontage along 5th Sideroad and an area of approximately 37.52ha.
