If you do not attend at the hearing it may proceed in your absence and, except as otherwise provided in the Planning Act, you will not be entitled to any further notice in the proceedings.


If you wish to be notified of the decisions or a change to the conditions of the Committee of

Adjustment for the Township of Adjala-Tosorontio in respect of the proposed concurrent consent and minor variance, you must make a written request to the Committee of Adjustment at the above noted address. If a person or public body that files an appeal of a decision of the Committee of Adjustment in respect of the proposed consent and/or minor variance and does not make an oral or written submission to the Committee of Adjustment before it gives or refuses to give a provisional consent, the Ontario Land Tribunal may dismiss the appeal.

EXPLANATION OF THE PURPOSE AND EFFECT OF THE PROPOSED CONSENT Consent B/06/23 (Hawkins)

An application has been made for consent under file number B/06/23 for consent to create a new residential lot on Pt Lot 14, Concession 3, Geographic Township of Tosorontio, Township of Adjala-Tosorontio (6443 Concession Road 3). The subject property has frontage of approximately 152m along Concession Road 3 and an area of approximately 7.67ha. The proposed vacant severed lot will have approximately 60.9m frontage along Concession Road 3 and an area of approximately 0.81ha. The proposed developed retained lot will have approximately 91.4m frontage along Concession Road 3 and an area of approximately 6.86ha.
