## EXPLANATION OF THE PURPOSE AND EFFECT OF THE PROPOSED MINOR VARIANCE A/04/23

An application has been made for a minor variance to Township Zoning By-law No. 03-56 under file number A/04/23 to permit construction of an addition to a legal non-complying structure that will not meet lot standards. The proposal is to construct an addition with a front yard setback of 21.4 metres where 30.0 m is required. The existing single-family dwelling is currently legal non-complying with a front yard setback of 24.6 metres where 30.0 metres is required within the Oak Ridges Moraine Linkage (ORM L) Zone, on Part Lot 4, Concession 6, Geographic Township of Adjala, Township of Adjala-Tosorontio (1488 Concession Road 7).
