A copy of this notice is being sent to all persons assessed in respect of land as noted in the Assessment Roll within 60 metres of subject property. If you do not attend the hearing, it may proceed in your absence and, except as otherwise provided in the Planning Act, you will not be entitled to any further notice in the proceedings.

If you wish to be notified of the decision of the Committee of Adjustment in respect of the requested minor variance, you must have appeared in person or by counsel at the hearing and have filed with the secretary/treasurer a written request for notice to the Committee of Adjustment at the above noted address according to Section 45(10). The Planning Act requires

that you be notified that if a person or public body who has an interest in the matter files an appeal of a decision of the Committee of Adjustment in respect of the requested minor variance the Ontario Land Tribunal (OLT) may dismiss all or part of the appeal without holding a hearing under section 45(17) of the Planning Act, R.S.O. 1990.

**EXPLANATION OF THE PURPOSE AND EFFECT
OF THE PROPOSED MINOR VARIANCE
A/06/23**

An application has been made for a minor variance to Township Zoning By-law No. 03-57 under file number A/06/23 to permit construction of a detached accessory structure that will exceed the height of the existing single-family dwelling. The existing single-family dwelling is 3.96 m (13 feet) and the proposed detached accessory structure is 5.48 m (18 feet). The current by-law does not allow for an accessory structure to exceed the height of the single-family dwelling, meaning a minor variance is required. All other provisions of the zoning by-law will be met within the Rural (R) Zone, on Part Lot 16, Concession 2, Geographic Township of Adjala, Township of Adjala-Tosorontio (8898 County Road 1).
