ZONING BY-LAW AMENDMENT APPLICATION Z/17/21

TAKE NOTICE that the Council of the Corporation of the Township of Adjala-Tosorontio has received an application under the Planning Act, R.S.O. 1990, as amended, for a Zoning By-law Amendment for property located on Part of Lot 31, Concession 3, geographic Township of Tosorontio, Township of Adjala-Tosorontio (8572 30th Sideroad).

SYNOPSIS: To permit construction of a detached accessory structure to be located in front of the single-family dwelling.

AND TAKE NOTICE that considering the restrictions due to COVID-19, the Council of the Corporation of the Township of Adjala-Tosorontio will hold a Virtual Public Meeting on Wednesday, December 8th,2021 at 6:00 p.m. at a Regular Council Meeting.

There will be a commenting period from November 15, 2021 to December 3, 2021 on the mentioned reports in such a way that the public can participate by sending their comments through letters, faxes, emails, voice messages, video clips or by registering with the Clerk's Department, to speak at the public meeting. Comments received after the commenting period will not be placed on the agenda, however they will be received by the Clerk's Department, clerk@adjtos.ca, to be read at the meeting and kept on record with the application.

AND TAKE NOTICE that these meetings will be live streamed by the municipality through our iCompass portal.

If a person or public body would otherwise have an ability to appeal the decision of the Council of the Township of Adjala-Tosorontio to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the Township of Adjala-Tosorontio before the by-law is passed, the person or public body is not entitled to appeal the decision.

If a person or public body does not make oral submissions at a public meeting or make written submissions to the Township of Adjala-Tosorontio before the by-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.



EXPLANATION OF THE PURPOSE AND EFFECT OF THE PROPOSED ZONING AMENDMENT Z/17/21 (8572 30th Sideroad)

Application has been made for rezoning (Z/17/21) on lands located on Part Lot 31 Concession 3, Township of Adjala-Tosorontio. The proposal is to amend the zoning of the property for a site-specific reason to permit construction of a detached accessory structure to be located in front of the single-family dwelling in the Rural (R) Zone. (Part Lot 31, Concession 3).

A By-law to amend Zoning By-law 03-57, as amended, of the Township of Adjala-Tosorontio

Part of Lot 31, Concession 3, 51R17514 Part 1 on Reference Plan, geographic Township of Tosorontio8572 30th Sideroad, Tosorontio (4301-020-005-09402)

Whereas Zoning By-law No. 03-57, as amended, constitutes the comprehensive Zoning By-law for the Township of Adjala-Tosorontio save and except those lands within the Oak Ridges Moraine area;

AND WHEREAS it is deemed necessary and desirable to further amend By-law No. 03-57, as amended;

AND WHEREAS this amendment will conform to the Official Plan of the Township of Adjala-Tosorontio;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF ADJALA-TOSORONTIO ENACTS AS FOLLOWS:

- 1. **THAT** Schedule "A-7" of By-law No. 03-57, as amended, is hereby further amended by changing the zoning on Part of Lot 31, Concession 3, geographic Township of Tosorontio, Part 1 of 51R17514 on Reference Plan from a Rural (R) Zone to Rural Exception 109 (R-109) Zone, as shown cross-hatched on Schedule "A", attached hereto.
- 2. **THAT** Section 5.4 Zone Exceptions for the Rural (R) Zone in By-law No. 03-57, as amended, is hereby further amended by adding the following:

Section 5.4.109 (R-109 Zone)

Schedule A-7, Part of Lot 31, Concession 3, Part 1 of 51R17514 on Reference Plan, geographic Township of Tosorontio.

Notwithstanding any provisions to the contrary of this By-law, the following altered and additional provisions shall apply to the lands zoned **R-109**:

i. That one (1) detached accessory structure shall be permitted in front of the single-family dwelling.

All other provisions of the Rural (R) Zone continue to apply.

THAT this By-law shall come into force on the date of passage and take effect the day after the last date for filing a notice of appeal, where no notice of appeal is received, or, where a notice of appeal is received, upon the approval of the Ontario Land Tribunal, and in either case, in accordance with the provisions of the Planning Act, R.S.O. 1990, Ch. P. 13, as amended.

THAT notwithstanding anything contrary to the rules of procedure, this By-law having been introduced and read a first and second time and be considered read a third time and finally passed this day of 2021.
