ZONING BY-LAW AMENDMENT APPLICATION Z/06/21

SYNOPSIS: To restrict the residential uses of the retained lot, to restrict the agricultural uses of the existing agricultural structures on the severed lot, and to recognize the size of the existing agricultural structure on the severed lot, as a result of a surplus farm dwelling severance.

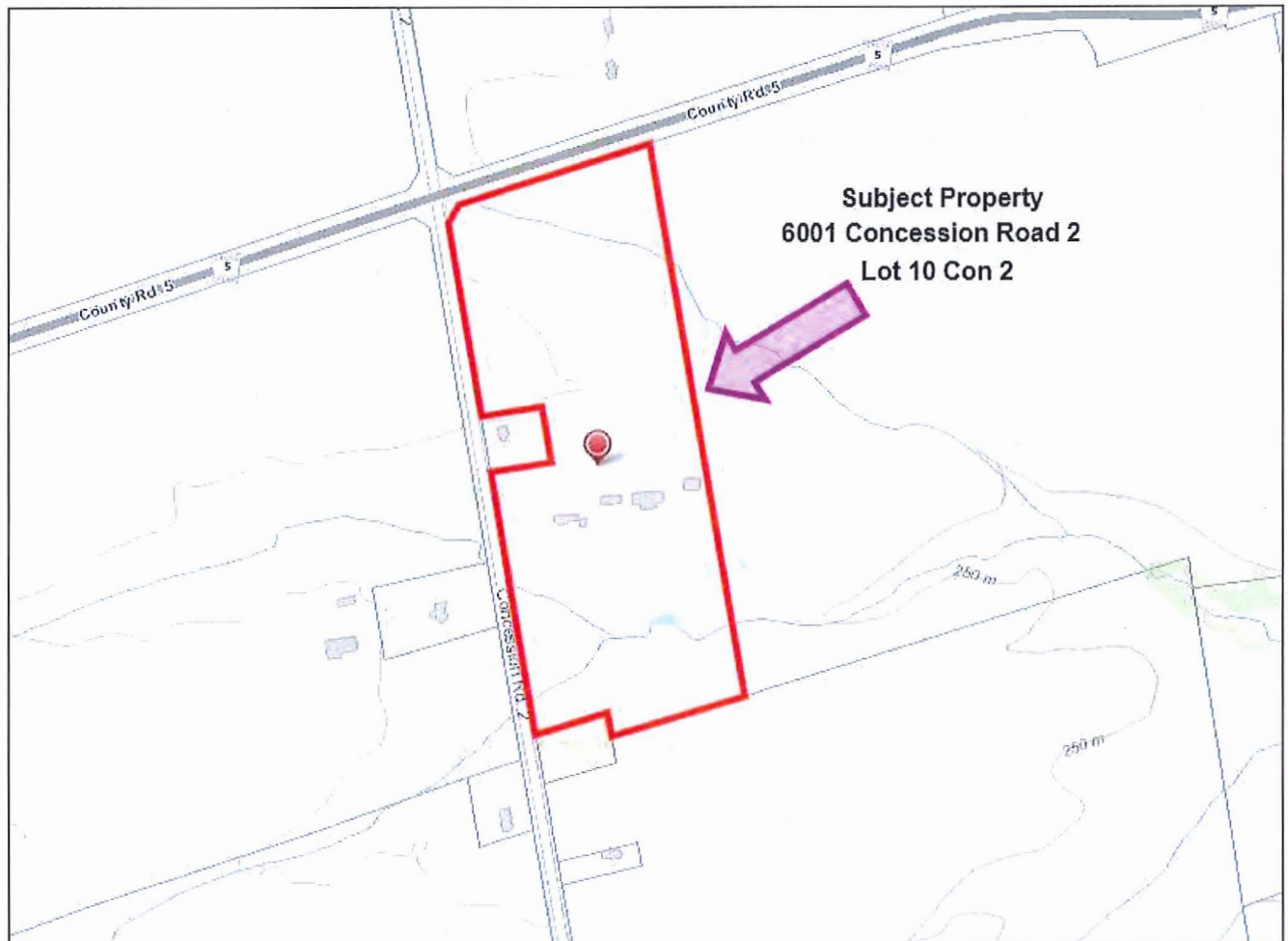

**EXPLANATION OF THE PURPOSE AND EFFECT
OF THE PROPOSED ZONING AMENDMENT
Z/06/21 (6017 Concession Road 2)**

Application has been made for rezoning (Z/06/21) on lands located on Lot 10 Concession 2, Township of Adjala-Tosorontio. The proposal is to amend the zoning of the property for a site-specific reason to remove agricultural uses on the severed lot and permit oversized accessory structure and sterilize the retained parcel to prohibit a residential use in the Agricultural (A) Zone (Lot 10, Concession 2).

A By-law to amend Zoning By-law 03-57, as amended, of the Township of Adjala-Tosorontio

**Part of Lot 10, Concession 2, geographic Township of Tosorontio, 6001
Concession Road 2 (4301-020-003-02200)**

Whereas Zoning By-law No. 03-57, as amended, constitutes the comprehensive Zoning By-law for the Township of Adjala-Tosorontio save and except those lands within the Oak Ridges Moraine area;

AND WHEREAS it is deemed necessary and desirable to further amend By-law No. 03-57, as amended;

AND WHEREAS this amendment will conform to the Official Plan of the Township of Adjala-Tosorontio;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF ADJALA-TOSORONTIO ENACTS AS FOLLOWS:

1. **THAT** Schedule "A-5" of By-law No. 03-57, as amended, is hereby further amended by changing the zoning on Part of Lot 10, Concession 2, geographic Township of Tosorontio, from an Agricultural (A) Zone to Agricultural Exception 126 (A-126) Zone, as shown cross-hatched on Schedule "A", attached hereto and the Open Space Conservation (OSC) Zone and the Agricultural Exception 127 (A-127) Zone, as shown hatched on Schedule "A", attached hereto.
2. **THAT** Section 4.4 – Zone Exceptions for the Agricultural (A) Zone in By-law No. 03-57, as amended, is hereby further amended by adding the following:

Section 4.4.126 (A-126 Zone)

Schedule A-5, Part of Lot 10, Concession Road 2, geographic Township of Tosorontio.

Notwithstanding any provisions to the contrary of this By-law, the following altered and additional provisions shall apply to the lands zoned **A-126**:

- a) Residential uses shall be prohibited

All other provisions of the Agricultural zone continue to apply.

3. **THAT** Section 4.4. – Zone Exceptions for the Agricultural (A) Zone in By-law No. 03-57, as amended, is hereby further amended by adding the following:
