

The Corporation of The Township of Adjala-Tosorontio

By-law No. 19-30

A By-law to make appointments to Advisory Committees, Local Boards and External Boards and Committees and to repeal By-law 16-18

Whereas Section 8 of the *Municipal Act*, S.O. 2001, c. M. 25, states that a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority; and

Whereas Subsection 5(3) of the *Municipal Act, 2001*, requires that all municipal powers, including natural person powers, are exercised by by-law; and

Whereas the Council of the Corporation of the Township of Adjala-Tosorontio deems it advisable to make appointments to Advisory Committees, Local Boards and External Boards and Committees; and

Whereas making appointments to Committees and Local Boards is deemed to be a natural person power; and

Whereas Council makes appointments to various Committees and Boards every four (4) years to coincide with the Municipal Election;

Now Therefore the Council of The Corporation of The Township of Adjala-Tosorontio enacts as follows:

1. **That** appointments to Advisory Committees (statutory / non-statutory) shall be confirmed as listed in Schedule "A" attached hereto forming part of this by-law.
2. **That** appointments to Local and External Boards and Committees shall be confirmed as listed in Schedule "B" attached hereto forming part of this by-law.
3. **That**, from time to time, changes to Schedules "A" and "B" are necessary due to vacancies created for various reasons or newly created Committees or Boards, it shall be deemed acceptable for Council to do so by resolution. The resolution shall be in effect only until the new appointments by-law is brought forward at the usual time at which Council strikes and confirms its appointments, and at which time a new by-law is enacted.
4. **That** as Council's term ends on November 30th of a municipal election year, and notwithstanding the coinciding expiry date of appointments to various Boards and Committees, the said appointments shall remain in place until such time as the newly elected Council has determined the new and/or renewed appointments,

and at such time as the newly appointed committees and Boards have met at which time they shall be deemed to be organized for carrying out their mandate.

5. **That** By-law 16-18 is hereby repealed.
6. **That** the provisions of this By-law shall take full force and effect with the passing hereof.
7. **That** notwithstanding anything contrary to the rules of procedure, this By-law be introduced and read a first and second time and be considered read a third time and finally passed this 13th day of May, 2019.
