TOWNSHIP/FINANCIAL UPDATE

2021 Budget

Council is currently working on the 2021 budget. We are committed to rehabilitating our infrastructure and maintaining existing service levels, while keeping property taxes affordable.

School Board and County Services

The township collects and transfers taxes to School Boards and the County of Simcoe. These taxes are used to maintain county roads and bridges, provide paramedic services, garbage pickup and waste transfer sites. They also provide financial contributions to the Stevenson Memorial Hospital, hospice services, long term care facilities, and subsidized housing in Simcoe County.

Outstanding Property Tax

As per the Municipal Act, property owners with delinquent taxes for two or more years will be contacted by the Township to arrange a suitable payment plan.

Water and Wastewater

Currently the water and wastewater systems of the township are being subsidized by all taxpayers. According to a recent report, the revenue that had been collected for water and wastewater had not covered the actual cost. This has resulted in a very large internal debt owed to the Township Working Fund that continues to increase annually. To resolve this situation, Watson and Associates (Township Economist) will be presenting a new sustainable financial plan to council in early spring. Council will hold a public meeting to hear from residents to come up with solutions to resolve this issue.

Council is considering options for the failing New Horizon Wastewater Plant which currently services 100 homes in Everett, as residents can be hooked into the new Farsight development's sewage plant. Council will contact residents when the developer presents costs to council.

Finances (as of December 2020)

<u>Total Internal Debt</u>: (money borrowed from general taxation) municipal water and wastewater users = \$3,418,848 and increasing.

Total Outstanding Receivables: Water, wastewater, and defaulting property taxes = \$5,255,656

Tax and Licence Payments

Payments for property taxes, water/sewer, dog licenses and burn permits can now be paid on-line with Mastercard, Visa through the Township online payment software, minimal service charge apply that goes to the service provider. Taxation Information

Tax bills are issued twice per year with each bill having two instalment due dates. The Interim Tax Bill is based on 50% of your prior year total taxes. Payments must be received on or before the due date. It is the property owner's responsibility to ensure payments are received by the due date. Late payment charges are subject to penalties of 1.25% added on the first day of default. Staff do not have the authority to waive penalty charges. Canada Post is not an agent for the municipality; therefore, penalty cannot be waived if the payment is not received on time.
